# Research Performance and Teaching Quality in Nigerian Tertiary Institutions: Evidence from Colleges of Education in North Eastern Nigeria

### **ABSTRACT**

The purpose of this study was to investigate the research performance and teaching quality in Nigerian Tertiary Institutions: Evidence from Colleges of Education in North Eastern Nigeria. Stratified random sampling was used to select a sample of 368 lecturers from Colleges of Education in North Eastern Nigeria. Questionnaire on Research Performance and Teaching Quality in Nigerian Tertiary Institutions: Evidence from Colleges of Education based on four point Likert technique was developed and used with the help of experts and related literature for the study. Validity of the instrument was ensured by consulting experienced professors and experts in the field. Reliability coefficient of the scale was 0.82. For analysis, mean ratings and standard deviation were employed. Lecturers' attitude towards research activities in Colleges of Education in North Eastern Nigeria was favourable, research innovations have great dealt of influence on improving the quality of teaching in Colleges of Education in North Eastern Nigeria, research innovations also have great dealt of influence on the job performance of lecturers in Colleges of Education in North Eastern Nigeria and all the strategies identified were significant in the enhancement of research activities and innovative teaching in Colleges of Education in North Eastern Nigeria. The study recommends college lecturers who exhibit good performance in research and quality teaching be rewarded both financially and socially in colleges of education in North Eastern Nigeria.

### INTRODUCTION

Research refers to the activities related to the acquisition of basic knowledge and can be designed to solve specific research problems which are strategic. Whereas teaching is the process of attending to people's needs, experiences

and feelings and intervening so that they learn particular things and go beyond the given. It is universally recognized that teaching, research and community service constitute the main functions of institutions of higher learning. These include universities, polytechnics, monotechnics,

colleges of technology and colleges of education.

The National Policy on Education (NPE) (2004), the National Policy on Science and Technology (NPST) (2003) and all subsequent related policy documents have placed emphasis on research as an integral part of national development. It is obvious that colleges of education are regarded as the pinnacle of the higher education system in Nigeria and also they undertake research (Ahmed, Ahmed and Shah, 2010). Rufa'i (2010)highlighted that there presumptions of very weak research culture in colleges of education. He further stated that even in the university sector where several academics are known to have showcased the products of their research in the international intellectual scene, the bulk of this research is said to be conceived in terms of publications, career advancement and intellectual prestige of the individual researchers, often with very little social relevance. Moreover, many believed that institutions of higher learning in Nigeria are very much left behind in the area of research and innovations. Nigerian higher institutions need to collaborate in research both domestically and on the international scene, but lack of facilities for collaborative research remained one of the greatest constrains (Salami and Hauptman, 2016).

Admittedly, poor motivation, poor and irregular funding, obsolete research facilities, inadequacy of qualified research personnel, lack of research focus and poor linkage between researchers and the industrial sector are yawning gaps in institutions of higher learning in Nigeria (Udoh, 2013). These constraints constitute serious limitations to research capacity and research capability of these institutions. Research in universities, polytechnics and colleges of education is routinely funded through the relevant supervisory bodies namely, the National Universities

Commission (NUC), the National Board for Technical Education (NBTE), National Commission for Colleges of Education (NCCE) and Tertiary Education Trust Fund (TETFund) (Udoh, 2013). The funding of research in these institutions has been generally poor and irregular. However, the federal institutions of higher learning are better funded and more autonomous than the state government owned institutions (Clark and Sedgwick, 2014).

The importance of education as a weapon against ignorance, conflict, disease and poverty demands quality in teaching. Higher education has been recognized as a fundamental instrument for the construction of knowledge development of human capitals all over the world (World Bank, 1999). According to Peretomode (2007), higher education is the facilitator, the bed rock, the power house and the driving force for the strong socioeconomic, political, cultural and industrial development of a nation as higher education. The quality of education in Nigerian tertiary institutions in recent years has reduced because of among other factors (the drift of many lecturers to countries where they were offered better remunerations) (Butt and Shams, 2013). syndrome to a large extent, attributable to inadequate incentives, poor equipped education system increasingly hostile working environment, inadequate social recognition and delay in payment of teachers' salaries among others. The reliance on inexperienced and in some cases unqualified teachers in various educational institutions in the country definitely affects the quality of students' works and graduates who are eventually employed to service the educational manpower needs, as well as the economy (Henson, Hull and Williams, 2010). This vicious circle contributes to the lowering status of education in the colleges



of education and even as the trend impacts on the economy negatively (Rufa'i, 2010).

Therefore, conducting research on research performance and teaching quality in Nigerian Tertiary Institutions: Evidence from Colleges of Education in North Eastern Nigeria is needed if qualitative and productive graduates are to be produced for national development. In light of the foregoing, the study is set to determine the research performance and teaching quality in Nigerian tertiary institutions: evidence from colleges of education in North Eastern Nigeria.

Producing graduates with required skills for facilitating quality teaching in Nigerian institutions of learning are part of the cardinal objectives of colleges of education. However, Okolocha and Baba (2016) observed that NCE graduates from colleges of education lack requisite competencies for optimal practical performance to the expectations and satisfaction of their employers. Beako (2017) attributed the trend to the poor teaching quality. Now public discussions frequently focus on decline in standard of education. Students' outcomes colleges of education do not match the government and parental investment (Hogg and Vaughan, 2005). Stakeholders are concerned about why the system is turning out graduates with poor background and lack requisite skills. Students' retention in colleges of education has been attributed to poor teaching methods employed by teachers' and the non-chalant attitude towards research innovations (Jimoh, 2015). The National Policy of Education states that "No Education system can rise above the quality of the teachers in the system (Federal Government of Nigeria, 2006). Oyosaju (2004) stated that the academic standard in all Nigerian educational institutions has fallen considerably below societal expectations.

Blumende (2001) corroborated this view when he reported that the decline in the quality of education cannot be ignored by anyone who is aware of the significant role of education as an instrument of societal transformation and development.

Although there is a growing interest on research performance by tertiary institutions, contributions from Nigeria, and North Eastern Nigeria in particular, remains one of the lowest (Awosan, 2014). Consequently, while higher institutions of learning in other part of the world (e.g. Europe, Americas, and Asia) are past utilizing the research to harness knowledge and solve problems; researchers in Nigeria spend valuable time researches with potentially impressive results that eventually end up laboratories without making any impact to knowledge and human development. From these aforementioned points this study determine the stands to research performance and teaching quality in Nigerian tertiary institutions: evidence from colleges of education in North Eastern Nigeria.

### Objectives of the Study

The main objective of this study is to determine the research performance and teaching quality in Nigerian tertiary institutions: evidence from colleges of education in North Eastern Nigeria. Specifically, the study intends;

- To ascertain the lecturers attitude towards research activities in colleges of education in North Eastern Nigeria.
- To determine the influence of research innovations on improving the qualitative of teaching in colleges of education in North Eastern Nigeria.
- To ascertain the influence of research innovations on the job performance of lecturers in colleges of education in North Eastern Nigeria.



iv. To identify the strategies for enhancing research activities and innovative teaching in colleges of education in North Eastern Nigeria.

#### RESEARCH METHODOLOGY

The research is a survey that adopted descriptive survey design. The study was conducted in North Eastern Nigeria, which has 13 Colleges of Education (Federal, State and Private). The population for the study comprised of 8,789 lecturers from colleges of education in the study area. The sample for this study comprised of 368 lecturers of colleges of education in North Eastern Nigeria which were drawn through a stratified random sampling technique. The instrument for data collection was Questionnaire on Research Performance and Teaching Quality in Nigerian Tertiary Institutions: Evidence from Colleges of Education. The instrument was

validated bγ experts in Educational Research from ATBU, Bauchi, subjected the instrument to both face and content validation in terms of clarity of instruction, proper wording of the items, appropriateness and adequacy of the items, in addressing the purpose and problems of the study. They rejected some questions which were replaced while suggestions were made on wordings and coverage. The reliability of the instrument was determined using Cronbach Alpha. A reliability coefficient value of 0.91 was obtained. Sambo (2005) stated that a reliability coefficient of 0.82 or above to be sufficient reliable for research purpose. The data collected were coded into Statistical Package of Social Science (SPSS). The package was used to run descriptive statistics of means scores and standard deviation for the research questions.

#### **RESULTS**

The result in Table 1 reveals the lecturers' attitude towards research activities in colleges of education in North Eastern Nigeria. The result in the table indicates that the standard deviation values ranged from (0.73 - 1.23) which showed

that each of the value was below 1.96. The result reveals that the mean responses in all the items fall within the mean range of 4 – 3indicating that lecturers' attitude towards research activities in Colleges of Education in North Eastern Nigeria was favourable

The table revealed that all the items had their mean values ranged from 3.12 – 3.57 and were above the cut-off point of mean 2.50 indicating that all the items were agreed by

the respondents as influence of research innovations on improving the qualitative of teaching in colleges of education in North Eastern Nigeria. The table further revealed that the standard deviation of all the 11 items ranged from 0.87-1.12 which imply that there was less variability in the opinion of the respondents.

Result in Table 4 shows the mean response and standard deviation on the strategies for enhancing research activities and innovative teaching. The table revealed that all the items had their mean values ranged from 3.20 - 3.52 and were above the cut-off point of mean 2.50 indicating that all the items were agreed by the respondents as strategies needed for enhancing research activities and innovative teaching in colleges of education in North Eastern Nigeria. The table further revealed that the standard deviation of all the 8 items ranged from 0.91 - 1.15 which imply that there was less variability in the opinion of the respondents.

#### FINDINGS OF THE STUDY

The findings of this study were:

- Lecturers' attitude towards research activities in Colleges of Education in North Eastern Nigeria was favourable.
- Research innovations have great dealt of influence on improving the quality of teaching in Colleges of Education in North Eastern Nigeria.

- iii. Research innovations also have great dealt of influence on the job performance of lecturers in Colleges of Education in North Eastern Nigeria.
- iv. All the strategies identified were significant in the enhancement of research activities and innovative teaching in Colleges of Education in North Eastern Nigeria.

### CONCLUSION

The roles of Nigerian institutions of higher learning comprise three major components: teaching, research and service. Institutions of higher learning and in particular colleges of education have an important role to play in research and producing qualitative graduates that would manage our schools. At present both the research and teaching quality and quantity are low to make the desired impact on national development. Therefore, policyoriented towards research and quality teaching needs to be stressed by all stakeholders in education.



#### RECOMMENDATIONS

- Weightage should be given to research performance during appointment of college lecturers in colleges of education in North Eastern Nigeria.
