

Heavy Metal Pollution and Ecological Risk Assessment of Sludge Deposits from Selected Wastewater Treatment Plants in Lagos, Nigeria

ABSTRACT

Sewage sludge is usually generated during treatment in wastewater treatment plants (WWTPs). Its disposal could cause the release of heavy metals into the environment, thereby, causing toxic pollution. This study involved the ecological assessment of sewage sludge samples which were collected from four government-owned wastewater treatment plants located at Alausa, Iponri, Abesan and Oke Afa in Lagos State, Southwestern Nigeria and analyzed the Cadmium (Cd), Copper (Cu), Lead (Pb), Nickel (Ni), and Zinc (Zn) contents using standard methods. The results show that all the heavy metals apart from Cd and Ni that were analyzed had concentrations that fell below regulatory limits, however, the ecological assessments used which included Contamination factor (Ci), Geo-accumulation index (I_{qeo}), ecological risk factor (E_r) and potential ecological risk index $(\sum E_r)$ recorded varying results. The correlation analysis showed that there was a strong positive correlation between Cu and Pb (0.971), Cu and Ni (0.995), and Pb and Ni (0.945) while there was a marginally negative correlation between Cu and Zn (-0.491), and Ni and Zn (-0.559). There were marginal correlations between Cd and Cu. Cd and Pb. Cd and Ni. Cd and Zn. as well as Pb and Zn. The Cf show a decreasing trend of Cd > Ni > Zn > Pb > Cu with sludge sample results varying from moderately polluted to severely polluted wih Cd accounting as the main culprit apart from Oke Afa WWTP. Also, the I_{qeo} results were in decreasing trend of Cd > Ni > Zn > Pb > Cu with results ranging from strongly polluted to very strongly polluted for cadmium and unpolluted for Cu. Pb and Zinc. The Er results were in decreasing trend of Cd > Ni > Cu > Pb > Zn with Cd far exceeding its limits and showing a very high ecological risk while Cu, Pb, and Zn did not pose any serious risk. $\sum E_r$ values indicate that apart from Oke Afa WWTP, the WWTPs exhibited very high ecological risk with Cd accounting for over 90% contribution and subsequent threat to the environment. It is therefore, recommended that sewage sludge from all the WWTPs be treated before reuse for other purposes such as agriculture.

INTRODUCTION

Sewage sludge is the residual solid material that is left after effluents from wastewater treatment plants (WWTPs) had been treated. The municipal wastewater itself usually consists of a mixture of domestic, commercial, industrial wastewater, and rainwater (Eriksson *et*

There is usually a large deposit of sludge during wastewater treatment in treatment plants and these deposits contain pollutants that are hazardous and must be carefully disposed of in such a way it does not constitute a hazard to the environment (Yang *et al.*, 2017; Sheng *et al.*, 2018). There are about three main ways that

sewage sludge can be disposed of and these include; By incineration, disposal to landfill sites, and recycled for agricultural uses Each of these methods has the potential of releasing heavy metals into the environment, thereby, causing toxic pollution as a result of non-biodegradable features of the constituent deposits of these toxins in sludge. Some of the heavy metals that may be found in sewage sludge include Lead (Pb), Cadmium (Cd), Zinc (Zn), Chromium (Cr), and Nickel (Ni), and their contents in sludge range from about 1mg/Kg to more than 1,000mg/Kg (Huang and Yuan, 2015; Huang and Yuan, 2016; Yang et al., 2017).

Lagos State in Nigeria with an ever rapidly growing population and relatively high number of industries has an ever-increasing demand for water and the resulting release of wastewater and sludge from its more than four treatment plants is a major concern. There is a of studies conducted on the paucity environmental characteristics and indices of sludge emanating from these treatment plants when compared to other countries with large numbers of industries such as the United States and China. In this study, sewage sludge samples were collected from four government-owned wastewater treatment plants located in Lagos

State, Southwestern Nigeria, and analyzed for heavy metals which were subsequently adopted to carry out an ecological risk assessment.

MATERIALS AND METHODS

Sample Collection, Pretreatment of Sludge, and Instrumental Analysis

Sludae samples were collected immediately after being dewatered from four state-owned wastewater treatment plants located at Iponri, Alausa, Oke-Afa, and Abesan in Lagos state, and transferred to the hydraulics and wastewater laboratory at the Federal University of Agriculture, Abeokuta, Ogun State, Nigeria. The samples were subsequently air-dried and pulverized into powder and stored in jars at room temperature. To determine the concentration of heavy metals, the sludge was first weighed and digested as per standard methods for the determination of the concentration of the selected heavy metals (USEPA, 1996). Analysis for each heavy metal parameter from each of the treatment plants was done in triplicates. The heavy metal concentration from all the sludge samples was compared with the European Union (EU) and the United States Environmental Protection Agency's (USEPA, 1996) maximum permissible limits for sediment/soil/sludge.

Methods of Analysis

To assess the level of pollution and potential ecological risk of heavy metals in the sewage sludge, the following indices were used; Contamination factor (C_f), Ecological Risk Factor (Er), Potential Ecological Risk Index (Ri), and Geo-accumulation Index (Igeo).

Contamination Factor (Cf)

The contamination factor is a single index indicator that is used to evaluate metal

contamination. It is a ratio between an element at the sampled location and the same element at a background site or reference value. It provides information on how a given element has been concentrated at the site under consideration relative to a background site. It is mathematically expressed as:

where C_f is the contamination factor, C_i is the concentration of metal of interest of a sludge

sample and C_b is the concentration of the same metal at a background or reference site. Four levels are used to describe the contamination

factor and are given below in table 2 (Suleiman *et al.*, 2018; Kang *et al.*, 2020).

The Geo-accumulation Index (Igeo)

The geo-accumulation index has been previously used to estimate the level of pollution of heavy metals in different environmental media (Muller, 1969; Lee *et al.*, 2013; Chen *et al.*, 2016). In this method, the index is calculated as

Where C_n metal is the concentration of the measured heavy metal in the sludge sample and B_n is the geochemical reference value of the metal n. The factor 1.5 is usually introduced to make up for any possible variations in the background or control values that may be attributed to lithogenic. Table 5 describes the levels of geo-accumulation.

Ecological Risk Factor (Er):

Ecological risk assessment is used to determine the nature of anthropogenic effects on the environment. The assessment of ecological risks of heavy metals in sewage sludge samples was done using the Ecological Risk factor E_r proposed by Hakanson (1980), expressed as follows;

Where E_r is the ecological risk factor, T_r is the toxic response factor of a certain metal. The values of T_r for each metal are arranged in the order of Zn=1<Cr=2<Cu=Ni=Pb=5<=30 (lwegbue *et al.*, 2013). C_n is the metal content in the soil and C_o is a background value (reference value of metals in soil). The following description of levels of ecological risk was given in table 3 (Suleiman *et al.*, 2018).

for heavy metals in sludge and E_r is an ecological risk factor.

The following terminology is used to describe the potential ecological risk index in table 5;

RESULTS AND DISCUSSION

Results of Physico-chemical analysis

The results of the physico-chemical analysis of the sludge samples are shown below in Table 6 and the abundance of heavy metals was in declining order: Zn > Ni > Pb > Cd > Cu and their range of concentration was recorded as Cd (0 – 60 mg/Kg), Cu (23 – 32 mg/Kg), Pb (44 – 106 mg/Kg), Ni (62 – 600 mg/Kg) and Zn (70 – 358 mg/Kg). It could be seen that apart from the sample Oke Afa WWTP, the cadmium

concentration exceeded both permissible levels endorsed by EU and USEPA. The concentrations of copper, lead, and zinc were all below the permissible limits while the concentration of Nickel apart from the sample from Iponri WWTP also fell below the maximum permissible limits. The results may be an indication that the WWTPs may not be functioning well and that the plants appear not to have been totally overwhelmed beyond its operating efficiency.

Descriptive statistics and Correlation analysis

The results of the statistical attributes of the sludge samples are shown below in table 7 with Ni having the highest mean, maximum concentration and range of values as well as highest variance. This could be attributed to its contents coming from multiple anthropogenic sources that may both be connected and unconnected to the other heavy metal sources.

The correlation analysis in Table 8 reveal that there were strong positive correlations between Cu and Pb (0.971), Cu and Ni (0.995), and Pb and Ni (0.945) while there was a marginally negative correlation between Cu and Zn (-0.491), and Ni and Zn (-0.559). there were marginal correlations between Cd and Cu, Cd and Pb, Cd

and Ni, Cd and Zn, as well as Pb and Zn. It is probable that Cu, Pb and Ni were produced from the same sources and that Cd may likely be produced from multiple sources other than where the other four heavy metals were sourced from.

The calculated values of contamination factor which are displayed below in Table 9 indicate the sludge samples from all the WWTPs were highly polluted with cadmium apart from the Oke Afa WWTP which did not record cadmium from its analysis. The results also show that the sludge samples ranged from low to considerably

contaminated apart from the Cd results in all the selected WWTPs. This is an indication that cadmium levels may be coming from industries that produce batteries, alloys, coatings (electroplating), solar cells, plastic stabilizers, etc which are common among industries in Lagos.

The results for geo-accumulation Index are displayed in Table 10 and it reveals that the I_{geo} values for Cu, Pb and Zn were observed to belong to the unpolluted category. However, the values for Cd apart from Oke Afa were classified

as ranging from strongly polluted to very strongly polluted while Nickel values ranged from unpolluted to strongly polluted. The I_{geo} values in the sludge were in decreasing order of Cd > Ni > Zn > Pb > Cu.

The assessment results of the ecological risk factor displayed in table11 show that it followed the trend in decreasing order Cd > Ni > Cu > Pb > Zn. The results show that Cadmium far exceeded the limits and showed very high potential ecological risk while nickel ranged from low potential to considerable ecological risk. Copper, lead and zinc did not pose any serious ecological risk. From the potential ecological risk factor results, Alausa, Iponri, and Abesan WWTPs all showed very

high ecological risk with cadmium acting as the main risk with contributions of more than 90% in these treatment plants. The implication of this result is that cadmium poses a very serious threat to the environment and additional treatment is required before the sewage sludge could be used. This result is similar to that obtained in Yang *et al.* (2017) where the sewage sludge produced very high ecological risks with cadmium also being the main culprit.

CONCLUSION

The heavy metals concentration were all within the regulatory limits apart from Cd and Ni, however, their ecological assessment revealed that cadmium posed a great threat to the environment while nickel did not pose as much threat even though its Er values varied across the four WWTPs. The potential ecological risk factor results show that only the sewage sludge from the WWTP at Oke Afa did not exhibit very high risk due to the non-availability of cadmium in its sludge contents. Cadmium is more likely to pose more harmful effects if the sludge samples containing it are released directly into the environment and therefore adequate remediation efforts should be put in place to minimize its effects before being put to reuse.
