# Impact of Ontology in Aviation Incident and Accident Knowledge Repository

#### **ABSTRACT**

The aviation industry is one of the most critical industries where access to quick and detailed information is very crucial for saving human lives and preserving the life span of the expensive fleet of aircraft. One of the most important problems with accident and incident reports in the aviation industry is that they are usually manually based or accessed and, in most cases, the outcome is usually based on hardcopy reports or standalone softcopies and are fragmented on the World Wide Web, and this makes logical inference cumbersome. However, documenting accidents and incidents in a database system is a good way to make these reports easily and logically accessible as knowledge for making informed decisions on any potential aspects to take note of, in order to enhance aircraft safety. This paper presents an Ontology-based knowledge representation language to facilitate explicit interpretation of domain resources and data. Coupled with its interoperability function, ontology presents the best choice for modelling such database domain. Ontology was developed in Protégé using the template of the accident and incident manuals and was tested by guerying it for accident and incident information which returned results based on the search criteria and the information in its database. Access to logical information in a database system for accidents and incidents in the aviation industry would facilitate the understanding of the structure of the data that can be used by humans as a source of knowledge of the things in the domain of a function for software for further computational task or analysis would go a long way in mitigating some avoidable incidences.



### INTRODUCTION

Aircraft accidents and incidents in the aviation industry (either military or commercial) cannot be totally averted; however, some are mostly as a result of improper information of previous incidences which if properly researched and grouped logically, can enhance the knowledge of players in the industry in mitigating such future occurrences. From an aircraft accident that occurred in Nigeria - a military aircraft Beechcraft King Air B350i that crashed in May, 2021 due to reported engine failure, to the aircraft incident of a commercial aircraft due to tyre burst in July 2021, and to that of the Siberian light aviation domestic flight reported in September,

2021 to have been crashed off the runway due to a heavy fog while landing with four fatalities, signals the fact that most of these accidents and incidents happened when it is least expected. This is a global challenge owing to the complexity of aircraft design; as such it is a common occurrence that aircraft components could fail (Zhao et al., 2018). However, it has been adjudged that most of the accident and incidents are as a result of human error and natural disaster that makes the aircraft system deviates from the predicted working and environmental conditions.

Usually, when an aircraft is involved in an accident or an incident, depending on the country investigating it, a team of experts are



There have been numerous cases of accidents and incidents in the aviation industry, Ontology serves as a tool that gives data meaning for an informed reasoning during a decision-making process (Su et al., 2016). It describes concepts and the relationships that can exist among the concepts and things in the domain of interest. It aids reasoning and can accommodate data from different sources. Ontology is made up of classes, properties, instances and the logical relationships that connect them all. Ontology can be represented in different representation language, the accident and incident ontology was implemented in web ontology language (OWL). The OWL is used out of all the knowledge representation languages due to expressivity (Shobowale, 2018) as it combines the resource description framework (RDF) and the extensible mark-up language (XML) flavours (Su et al., 2016). Ontology has been used in different context such as in regulating aviation supply chain management (Milambo & Phiri, 2019), in regulating cyber security (Talib et al., 2018; Aliu et al 2021), in software as a cloud services on the cloud (Otuka et al., 2017; Chinedu et al., 2021) to name a few.

#### LITERATURE REVIEW

Knowledge base systems stores data as information to support decision making process. Ontologies are multipurpose; it can be

used for solving issues in data modelling, guerying, knowledge base and decision support (Shobowale, 2018). Industries that have profited from the use of ontology includes: Healthcare (Health information regulation, sharing Health information, making Health recommendations accessible). Education, Supply Chain, Governance and Construction etc. Ontologies have been handy for data interoperability, flexible data exchange, distributed data management, and the development of reusable tools (Kondylakis et al., 2021). The work by (Asim et al., 2018) reported that owing to ontology capability to give explicit semantics and its interoperability and stressing the importance of reuse of domain knowledge, they concluded that Ontology makes domain knowledge more explicit and that with Ontology, it's easier to analyse domain knowledge. For aviation, data analysis of aviation is challenging, especially in the management of air traffic flow management (Aghdam et al., 2021). They further reiterated that proper management and analysis of diverse data can minimize human error and consequently aircraft accidents and incidents.

Ontology has seen some matured usage in many industries (such as the health care, transport, oil and gas to mention a few), in the transport industry for example. (Hughes et al., 2019) used 5065 free-text multi-lingual (German, French and Italian) safety incident reports from the Swiss Federal Office of Railway Transport was used to develop safety ontology. Different categories of injuries to passengers made up the classes. The ontology was queried using a graph database when information on incidents is required. Human evaluators were used for the validation. The aviation industry has seen some emerging usage in the aspect of using it as a database system. In recording aviation occurrences, (Kremen et al., 2017), developed a database for recording data on accident and incident records that occurred solely in the European region.

The work by (Saeeda, 2017), designed information extraction and semantic annotations iterative ontology for safety reports of aviation while (Ledvinka *et al.*, 2019), proposed ontology as a technology for data management in safety. They designed an ontology information system for integrating aviation safety data. Also, knowledge sharing

in aircraft maintenance and retrieval of database aircraft fault ontology was provided by (Yang 2011), using similarity matching algorithm based on nearest neighbour to retrieve results of the guery.

The work by (Aghdam et al., 2021) developed internet protocol suite-based aviation networks ontology using methontology methodology for the ontology development. Their scope was the engineering of flight messages ontology implemented in Protégé software. They concluded that the semantic web has solved the issue of finding meaning to data with ontology also known as knowledge graphs for connecting data and finding relationships through inference to make informed decisions. Also, (Ledvinka et al .,2018), developed aviation safety data collection and processing ontology information system for safety data while (Zhao et al., 2018), designed a construction risk-based aviation ontology and tested using the American Aviation safety reporting system. More so, an ontology for knowledge management procedures in aviation departures

was designed by (Su et al., 2016). According to (Haendel et al., 2018) ontologies defers from terminologies, ontologies define relationships between concepts making it easy for computational logical reasoning which then makes the drawing of logical conclusions from related assertions easy. Ontology comprises of a set of concepts (terms of the domain represented in classes and subclasses) together with their synonyms which is depicted in their annotations, individuals or instances that are members of the classes or subclasses, data and object properties that links the instances together as well as description-logic definitions that specify the formal relationships between the concepts. Terminologies are simply meaning of terms in the domain. Description logic in ontology makes the ontology logically consistent, this paper is concerned with the documentation of accident and incident data records for easy and prompt retrieval of information. Ontology can be developed using different editors, Table 1 highlights the differences in various editors.

#### **METHODOLOGY**

The incident and accident ontology model was developed in protégé-OWL using protégé 5.5.0 using the methodology in [Shobowale, 2018]. The steps below depict the process of ontology development:

# Step 1: Determine the Purpose and Scope of the Ontology

Determining the purpose and scope the ontology will serve is the first task in creating ontology. In this paper, the purpose of the ontology is to create a knowledge-based system to facilitate easy retrieval and updating

Competency questions also needs to be generated to get a good grasp of the scope of the ontology, this is a list of questions that the ontology knowledge based will give answers

#### Competency question:

- What Accident/Incident data should be stored in the ontology?
- Can the Accident/Incident ontology be integrated with other systems for further development?

#### Step 2: Knowledge Acquisition

The first thing to consider is to check if there is an existing ontology in the domain of interest that can be reused. If none exist, then the ontology has to be built from scratch. The incident and accident ontology was built from scratch as there is not a publicly one available based on the authors findings. The procedures manual of aircraft accident/incident investigation appendix H, part of occurrence identification section was used to develop the ontology.

### Step 3: Design and Development

This entails identifying:

 The key concepts in the domain are the classes and its hierarchies which will form the classes and its subclasses. For occurrence identification, history of flight section, the history of flight will be a class while Airline operation (Air Transport Operations) will be a subclass. Type of operation will be a subclass of Airline operation (Air Transport Operations) while the code 0101, 0102 and 0103 will be a subclass of Airline operation (Air Transport Operations). Instances also known as individuals are the components the ontology is built on, as in ontology classify instances. In our accident and incident ontology, instances such as 'Accident\_01', 'Accident\_02', and 'Incident\_01' are classified by their ontology and returns results based on the other instances that make up the accident and incident ontology.

Properties which are either object or data properties or also called characteristics connect the instances to make them form a relationship. Object properties are used to form a relationship between two instances while data properties connect one individual with an attribute data. In the accident and incident ontology, an object property connects two instances Accident 01 and Passenger through the object property "has Type of Operation", while an instance Accident 01 connects with an attribute data (NAF203 which is of type string) through the data property 'has Registration'.

#### Step 4: Evaluation and Validation

The evaluation and validation serve to ensure quality assurance of the ontology. The evaluation is to measure if the purpose of the ontology has been satisfied (can knowledge can be inferred from the ontology?) and the task (the knowledge-base, information search and retrieval) the reason the ontology was built can be accomplished. The evaluation and validation can be measured on logical criteria; checking for inconsistent in the ontology using the reasoner implies modeling errors, making it impossible to be used for automatic deductions in applications. Logical consistency is the basis for a useful ontology. Ontology must be logically complete with axioms such as class disjointness, property restrictions. complex statements expressions (Shobowale, 2018).

# Knowledge Representation and Description (Modelling in OWL-DL)

Knowledge representation that is commonly used for ontology development is Web ontology language description logic (OWL-DL), a member of first-order predicate logic. The Attributive, Language with Complement (ALC) are the basic description

logic and the classes, properties and individual (instance) are the basic building blocks. Some OWL-DL language constructs such as *owl:* cardinality cannot be expressed using ALC, an upgrade to a higher description logic SHOIN (D) (S for ALC and property transivity; H for property hierarchies, O for one element closed classes, I for inverse properties; N for cardinality restrictions and D for datatypes) was implemented as it contains ALC and more language constructs for more expressivity [Shobowale, 2018]. By default, there are two classes in OWL-DL which are the owl: Thing (the main class) and owl: Nothing (the empty class that stores the inferred model). A

complex class can be constructed using equation 1:




Figure 1: DL Architecture for Modelling Accident and Incident data

The axioms/statements of the Description logic knowledge base are TBox and ABox Statements (Figure 1).

Domain knowledge modelled in ontology comprises of the TBox statements and the ABox statements.

Accident in Figure 1 is an expression that also states that Accident\_Code is a variant of Accident and Accident is a type of Occurrence Classification.

ABox statements – these are asserted knowledge about individuals (instances) from the terminology of the *TBox*. The statement,

Occurrence Classification 

∃ has Type of Operation); denoting all Occurrence Classification must have type of operation named type of operation which can be Scheduled, Non-Scheduled or Unknown. The asserted knowledge in Figure 1 will now be:




Figure 2: Description Logic Query

Accident code: has Type of Operation (Scheduled); that is Accident code a variant of Accident and it has type of operation Scheduled, meaning the aircraft that was involved in the accident was on a scheduled flight. What can be deduced from this information that the aircraft has passed the airworthiness before it was allowed to fly, it can therefore be deduced that negligence was not a factor in the accident and that other causes such as human error, deviation from the predicted conditions are the probable cause. Search for Accident that has type of operation to be on schedule will return Accident 01 and other attributes of the Accident 01 can be

viewed for further action (Figure 2). The syntax on DL Query is "Accident and has Type of

Operation value Scheduled".

Classes can fall into atomic classes and properties (names of classes and properties) and complex classes and properties (constructed using description based on description logic language and then assign them names in the TBox). Accident / Incident Ontology atomic classes are Occurrence Classification, Accident, Incident and atomic property has Location Near. The TBox part is used to define the complex classes about the location where the accident or incident occurred is modeled as:

In conclusion, the TBox states the semantic relationships between individuals of the ABox and their properties while the ABox describes the specifics of the domain by using the classes and properties in the TBox.

#### **RESULT AND DISCUSSION**

The accident and incident data report that was used to develop the ontology knowledge base is shown in Figure 3 with the output of the ontology visualization tool, OWLViz. The class after the super class (owl:thing) is the occurrence classification class. The occurrence classification class has the accident and incident as its subclasses as both subclasses are what other entities in the ontology defines.




Figure 4: Occurrence Classification Accident Class




Figure 5: Occurrence Classification Incident Class

The accident and incident report manual was developed into the accident and incident ontology as shown in Figure 4. Every other data in the manual was categorized into the aircraft accident and incident data while the main entities which are the accident and the incident inherits the subclasses from the

aircraft accident and incident data. The accident class is disjointed with incident classes, which implies that the accident is different from the incident. In Figure 5, the incident is class is shown to be disjointed with the accident class.

object properties (Figure 7) maintain a link between two instances.





Figure 6: Data Properties of the Accident and Incident Ontology




Figure 8: Instances of the Accident and Incident Ontology






Figure 9: Class Hierarchy of the Accident and Incident Ontology




Figure 10: Accident Ontology Inferred Classes






Figure 11: Incident Ontology Inferred Classes

The instances of the accident and incident ontology are depicted in Figure 8. Instances are the main entities that the ontology works on. The class hierarchy which encodes all the main subheadings of the accident and incident manual is shown in Figure 9. For a meaningful knowledge base, inference has to occur, in protégé, this is achieved with the use of a reasoner, the comparison of the different types of reasoner

that can be used can be found in Table 2. Figure 10 shows the inference that was returned when the reasoner is started, the inferred classes are shown in yellow, this implies that the data in the knowledge base for that particular accident (Accident 01) are from the subclasses in the description box under the types heading highlighted in yellow (Figure 10). This also applies to the incident inferred model in Figure 11.

#### CONCLUSION
