

# Optimal Reconfiguration of 8A & B 11kV C-2 Maitama Feeder for Power Loss Reduction and Improved Reliability

#### ABSTRACT

Technical losses have been the major problem in radial distribution system. As such, a distribution network reconfiguration based on Bat Algorithm for real power loss reduction and improved reliability is proposed in this paper. A reconfiguration model based on Bat Algorithm is used to determine the optimal position of the sectionalized and tie switches that will reduce the active power loss and improve reliability. The proposed method is implemented on standard IEEE 33 Bus distribution test system and applied on 11kV 8A & B C-22 Maitama Injection Substation feeder in Federal Capital Territory (FCT), Abuja Nigeria. In IEEE 33 bus distribution test system, the optimal location of the tie switches was found to be (5), (11), (22), (31), and (35), a power loss of 74.82kW was obtained which gives about 63.93% power loss reduction. 1.1408, 0.3145 and 0.3772 was obtained for SAIDI, SAIFI and ENS respectively. In 11kV 8A & B C-2 Maitama Injection Substation feeder, a power loss of 0.4465kW was obtained which gives about 75.58% power loss reduction while 0.9328, 0.00007924 and 0.4043 was recorded for SAIDI, SAIFI and ENS respectively which is about 42.79% for reliability improvement with respect to SAIFI. The optimal locations of tie switches were found to be positions (8-9) and (16-24).

#### INTRODUCTION

Distribution network reconfiguration (DNR) is a network altering process performed by power utilities of distribution networks for a number of purposes. This is achieved by modifying the connection status of distribution network branches by switching on/off normally closed/open switches in the system such that an optimal network topology achieved, which gives the best performance with respect to some specified objectives (Tuladhar et al., 2016). Distribution systems operate in radial configuration with many switches located along the network at strategic points. The switches are sectionalized and tie switches. Sectionalizing switches are the protective devices that operate in conjunction with backup circuit breakers or reclosers (Gonen, 1986). In general, power systems in steady state analysis are operated with balanced three-phase generation and

likewise the loads in the transmission lines but this is not the same with the distribution system particularly for radial distribution systems because of the single-phase, two-phase and three-phase loads. That is why that along the line in the distribution systems, about 40% of the produced electrical powers are loss as a result of low voltage and high current in the network (Reddy et al., 2017). Also, high resistance to reactance ratio has contributed to more power loss and voltage drop in distribution system. But, the power loss reduction, improve voltage and reliability of the distribution systems can be achieved through many ways such as reconfiguration, load feeder balancing, capacitor placement and distributed generator but reconfiguration is the most preferred method because of its cost effective and no extra equipment required apart from the existing equipment. Distribution network reconfiguration

(DNR) is the process of varying the topological arrangement of distribution feeders in a way of changing the open/closed status of sectionalizing and tie switches while maintaining the system constraints on satisfying the operators' objectives (Nguyen & Truong, 2015).

Therefore, it has been observed that the objective of reconfiguration of the distribution network was to find out the spanning tree (radial network) from the given graph (distribution network) in a way that it must have a least active/real power loss while all the operational constraints are met (Abubakar et al., 2019). Reconfiguration of distribution network was first proposed by Prasad et al. (2015) to minimize the losses in the feeder. They tried in formulating the problem of mixed integer using the discrete branch and bound method which a non-linear optimization problem to solve it. Other examples are these evolutionary algorithms, Genetic Algorithm (Gupta et al., 2014), Particle Swarm Optimization (Dahalan & Mokhlis, 2012), Modified Honey Bee Mating Optimization (Javad et al., 2012), Modified Culture Algorithm (Verma & Singh, 2018), Cuckoo Search Algorithm (Nguyen, & Truong, 2015), Artificial Bee Colony Algorithm (Dharani et al., 2014), Ant Colony Optimization (Abdelaziz et al., 2013) and Grey Wolf optimization (Reddy et al., 2017) etc.

Mendoza *et al.* (2009) defined reliability in power system as a level of which the performance of components in a bulk system of electricity is delivered to the customers in an acceptable standard. Three reliability indices used in this paper are System Average Interruption Frequency Index (SAIFI), System Average Interruption Duration Index (SAIDI) and Energy Not Supplied (ENS).

# OPTIMIZATION TECHNIQUE Overview of Bat Algorithm

Bat Algorithm (BA) is a population based evolutionary optimization algorithm that imitates the behavior of bat animals to take their prey as developed by Xin-She Yang in 2010 (Gandomi & Yang, 2014).

# Rules of Bat Algorithm

1. All bats use echolocation to sense distance to food/prey and obstacle.

- 2. Bats fly randomly with velocity  $V_i$  at position  $X_i$  with a frequency  $f_{min}$  varying wavelength  $\lambda$  and loudness  $A_o$  to search for prey.
- 3. Loudness can vary from a large (positive)  $A_o$  to a minimum constant value  $A_{min}$ .

## Population

Initial population is a number of bats BA (n) that are generated randomly. The numbers are in between 10 and 30.

#### **Movement of Virtual Bats**

The abovementioned rules can be translated into frequency, velocity and position of the solutions which can be calculated based on the following formulas:

Where the value of  $\beta$  is a random number within the range of [0,1],  $f_i$  is the frequency of the *ith* bat that controls the range and speed of movement of the bats,  $V_i$  and  $x_i$  denote the velocity and the position of *ith* bat, respectively and  $x_{gbest}^t$  stands for the current global best position at time step t.

Equation (4) gives the new solution for each bat that generated locally using random walk as given below

Where  $\varepsilon \varepsilon [-1, 1]$  is a random number,  $X_{old}$  is the solution in the current optimization solution set, and  $A^t = \langle A_i^t \rangle$  is the average loudness of all the bats at time step t.

## Bat Loudness and Pulse rate

The loudness of bat decreases once a bat has gotten a food while the pulse rate emission increases. When  $A_{min} = 0$ , it shows that the bat has just gotten a food and thereby stop emitting any sound.

At the first step of algorithm, the values of these two parameters are chosen randomly, generally  $A_i(0) \in [1, 2]$  and  $r_i(0) \in [0, 1]$ . Equation (8)

Where SWloc is the switch location for sectionalized and tie switches,  $\beta$  is a random number between [0, 1],  $f_i$  denotes the best positions of the optimal network switches and to control the pace and range of the bat's movement, *V* is a current best location and  $f_i$  is given in equation (9). Then the new solution or position for the bat can be generated by the equation given below,

#### **REVIEW OF SIMILAR WORK**

A lot of relevant literature with regards to reconfiguration of distribution feeder for loss minimization and improved reliability has been published in order to address the issue in distribution system. Gupta et al. (2014) proposed a distribution network reconfiguration for power quality and reliability improvement using Genetic Algorithm. The system reliability indices like SAIDI. SAIFI and ENS were used to evaluate the reliability of the distribution network. The effectiveness of the proposed algorithm was investigated on two different IEEE standard test distribution system (33and 69) bus and the result that was obtained was compared with the existing GA based method and degree of satisfaction of Pareto optimal solution of 33 and 69 bus systems as a way of solving multiobjective reconfiguration problem of distribution systems. Sedighizadeh et al. (2017) presented a multi-objective framework for optimal network reconfiguration in power loss reduction and improved reliability. They used fuzzy membership to transform the objective functions into same scale and then to determine the satisfaction level of the afforded solution using fuzzy fitness. The efficiency of the proposed method was tested on IEEE 33 and 69 bus distribution test system and was implemented using MATLAB software package. A power loss 139.53kW was recorded and the values of SAIDI, SAIFI and ENS were given as 1.6423, 1.1782 and 1.9052. Srividhya *et al.* (2020) proposed a reliability improvement of radial distribution system through feeder reconfiguration based on Binary Particle Swarm Optimization. The effectiveness of the algorithm was tested on standard IEEE 33 and 69 bus distribution test system. A power loss 150.22kW and 1.3627, 2.2584 and 0.6034 for SAIDI, SAIFI and ENS was recorded respectively.

This brief review of recent relevant literature has shown the important of reconfiguration in distribution system as it helps to reduce the active power loss and improve the reliability. The research aims to develop a reconfiguration model that will reduce the power loss and improve reliability.

# MATERIALS AND METHODS

# Model of Network Reconfiguration

The power loss reduction and improved reliability are the objective function for this network reconfiguration.

#### **Real Power Loss Reduction**

The minimization of the total real power arising from feeders can be calculated as follows

#### **Reliability Indices**

I. System Average Interruption Index (SAIDI) is the average of the total duration of interruptions affecting customers during a given year.

These objectives are the function of active load demand  $P_i$  and apparent load demand  $Q_i$  of the N system load points as well as of the failure rate  $\lambda_i$ , repair time  $r_i$  and the unavailability  $U_i$  for the each of the load point of the line. The above objectives functions are subjected to constraint that must be satisfied at same time. These constraints are given as follows;

#### **Single Objective Function**

The Single Objective Function (SOF) is a function which brings in all the objectives into a composite function. This composite function is all about parameters of the network to be selected which are important to the objectives. Therefore, considering the aforementioned three objectives, the Single Objective Function proposed for this research work shall be given in equations below

 $OF_1$  is given in equation (10) and  $OF_2$ ,  $OF_3$  and  $OF_4$  is given in equation (12), (13) and (14) respectively.  $w_1, w_2, w_3$  and  $w_4$  are the weighting power incorporated to assign the relative dominance to these  $OF_1, OF_2, OF_3$  and  $OF_4$  respectively.

#### Backward-Forward Sweep (BFS) Method for Power Flow Analysis

The Backward-Forward Sweep (BFS) method is based on the imperative condition that the network ought to be radial as it is the most cases in distribution systems, whereby that the replicate of current paths is possible while the topology of radial is to limit the short-circuits power and reduce the protection complexity (Gomez-Exposito *et al.*, 2008). This method is simple in practice, start finding the line currents from backwards (from the farthest buses) up to the reference bus which may be substation and assuming that the voltages are known, then it proceeds forward using the computed currents to update the voltages (Augugliaro *et al.*, 2008 & kaur & Gill, 2017).

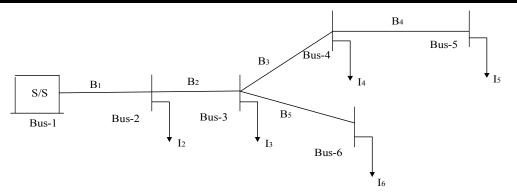


Figure 1: A simple 6-bus radial distribution network (Reddy et al., 2018; Verma & Singh, 2018)

In radial distribution network, the large R/X ratio causes a major problem in convergence of conventional load flow algorithms. Assuming in a balanced RDN, the network can be

represented by an equivalent single-line diagram. The injected current at buses can be calculated as given by

When adopting the backward sweep using KCL for Figure 1 which is given as (Reddy *et al.,* 2017) Branch current can be written in terms of injected current is as follows (Verma and Singh, 2018).

But the correlation among the load current  $(I_{L,n})$ and line currents  $(I_{B,K})$  in Bus-injection to Branch-current (*BIBC*) matrix structure is given as

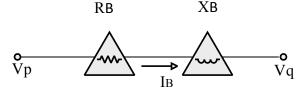


Figure 2: Representative of a branch Bus (Reddy et al., 2018)

When considering the forward sweep, KVL covers for the receiving end voltage of one branch of p.q nodes as given below is Figure 2.

 $P_i$  and  $Q_i$  are the constant active and reactive power loads connected at bus -i.  $I_i^K$  and  $V_i^K$  are the equivalent current injection and bus voltage of i<sup>th</sup> bus and for k<sup>th</sup> iteration respectively.

#### **Bat Algorithm Parameters**

The parameters used in BA for simulation are as follow: dimension (D) = 5,  $\alpha$ (A) &  $\gamma$ (r) =0.9,  $F_{min}$  = 0,  $F_{max}$  = 2, *iter<sub>max</sub>* = 100 and population = 20.

#### Implementation to Solve the Optimization Problem

1. First, read the system data inputs (load data, line data and network topology)

2. Select the lower and upper bounds limit for the parameter to be tuned, determine BA setting such as frequency, pulse rates, loudness and the maximum number of iterations.

3. Generate the initial bat population randomly in the feasible range. Each bat indicates a promising optimal location of switching unit in the distribution network.

4. Evaluate the fitness function, in this step, the total active power loss and reliability indices of the objective function can be calculated by using BFS method for each solution or bat.

5. Choose the better bat in the population (minimum total active power loss and minimum values of reliability indices).

6. Update frequency, velocity, and location of bats using equation (1), (2) and (3).

7. Run the load flow and determine the total active power loss and reliability indices with the updated population using equation (10)

8. Check the stopping criterion. The stopping criterion can be the maximum number of iterations to update the Bat algorithm population or a specific value which should be reached by the objective function.

9. Choose the best compromise solution with the minimum value of active power loss and reliability indices as the objective function.

10. The best minimum objective function is compare with the base case. Power loss reduction and reliability is calculated.

#### Data Collected and Analysis

The following data were collected from Abuja Electricity Distribution Company (AEDC). These are as follow:

1. C-2 Maitama Injection Substation schematic diagram

2. C-2 Maitama Injection Substation 11kV feeder line and bus data

3. Failure rate and repair time of the line for 8A & B 11kV feeder from the C-2 Maitama Injection Substation.

#### **RESULTS AND DISCUSSION**

This section discusses the results obtained when the proposed algorithm is implemented on IEEE 33 bus and then applied on C-2 Maitama Injection Substation 8A & B 11kV Feeder.

# The Standard IEEE 33 Bus Distribution Test System

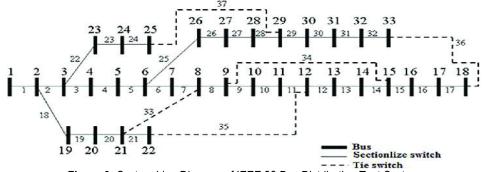


Figure 3: System Line Diagram of IEEE 33 Bus Distribution Test System

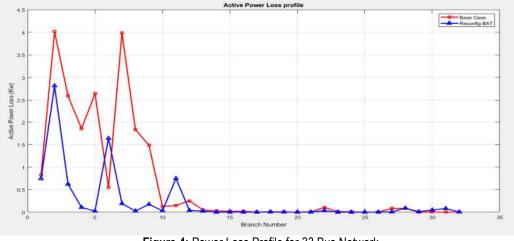


Figure 4: Power Loss Profile for 33 Bus Network

The distribution test network has a voltage of 12.65kV and the base power of 10MVA and the load of  $(47.5 + j \times 2300)$  KVA. The system consist of 33 buses, 1 main feeder, 3 lateral, 32 sectionalize switches and 5

tie switches. The system line diagram is depicted in figure 3 while the bus data is given in (Gupta et al., 2014). The optimal solution of IEEE 33-bus using the developed algorithm was depicted in Table 1. The optimal location of tie switches was found on 5, 11, 22, 31 and 35 with an active power loss reduction 63.93% (74.82kW) as compare to the active power loss of (207.44kW) of the initial configuration. Figure 4 shows a plot of the active power loss as a function of number in 50 iterations. The SAIDI, SAIFI and ENS are 1.1408, 0.3145 and 0.1874 respectively as compare to the initial of 1.2463, 0.3212 and 0.3772. The computation time for the developed bat algorithm is 1.696363 seconds which is evidence that the developed algorithm has improved the network.

#### 8A & B 11kV Feeder

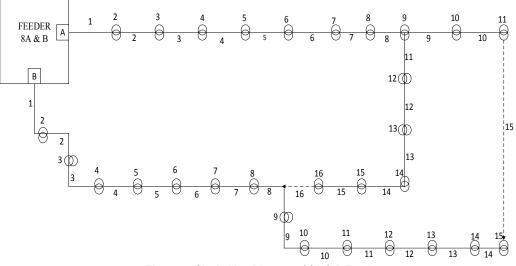


Figure 5: Single Line Diagram of 8A & B Feeder

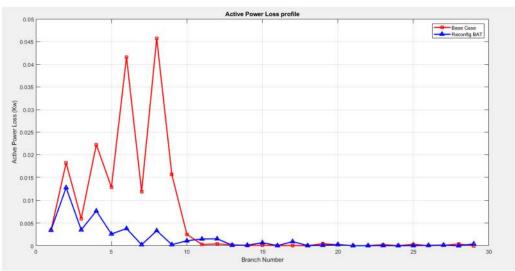


Figure 6: Power Loss Profile Before and after Reconfiguration for C-2 Maitama 11kV 8A & B Feeder.

The 8A & B 11kV feeder consists of 29 buses, 28 sectionalize switches and 2 tie switches which is fed from C-2 Maitama Injection Substation. The network is a single 33/11kV injection substation which is fed from two incoming 33kV namely AT3 Maitama by-pass Katampe and AT5 central Area owned by Abuja Electricity Distribution Company (AEDC), the defunct NEPA. The total active power obtained after the reconfiguration is 0.4465kW and the total active power loss before reconfiguration was 1.8286kW. This shows that there is a power loss reduction of 75.58%. The SAIDI, SAIFI and ENS before the reconfiguration are 1.8516, 0.000138253 and 0.4043 respectively. After the

reconfiguration, the values for SAIDI, SAIFI and ENS is 0.9328, 0.00007924 and 0.2563 respectively which shows 42.79% reliability improvement in respect to SAIFI. The optimal positions for the tie switches after the reconfiguration is (8-9) and (16-24) which has changed from (11-15) and (8-16) before the network topology is reconfigured. Figure 6 shows the power loss profile for 8A & B 11kV feeder. Table 2 gives the summary of C-2 Maitama Injection Substation 11kV 8A & B feeder network performance before and after reconfiguration. The schematic diagram of 8A & B feeder is depicting on figure 5 and the bus data given Table 3.

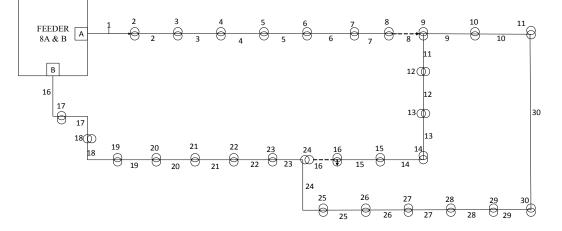


Figure 7: The Reconfigured Networks for C-2 Maitama 8A & B 11kV Feeder

# CONCLUSION

A bat algorithm optimization has been presented in this paper for a radial distribution network reconfiguration problem for multiobjective function. The proposed DNR was aimed at minimizing the active power loss and improved reliability. The effectiveness of the algorithm was tested on standard IEEE 33 bus distribution test network and applied on C-2 Maitama Injection substation 11kV 8A & B Feeder. The main advantage of this proposed algorithm is its simplicity to implement and it has a very low computational time which is very essential for a medium and large multi-scale distribution network.
