

Performance Evaluation of an Optimally Designed Substation Grounding Grids

ABSTRACT

The inadequacy of proper grounding or the lack of it leads to disruption of services, damages to equipment under fault conditions and personnel injury or death. This paper applied the Harmony Search Algorithm (HSA) and Genetic Algorithm (GA) to determine an optimal design of Substation grounding grids. Sets of data were collected from the proposed substation site. The area of land for the proposed substation is 70m x 70m. For ease of the design, the site is divided into grids of 10m intervals along the longitudinal and transverse plane. The apparent resistivity data obtained from the testing equipment serves as inputs to sets of equations used in determining the Performance metrics for an optimal design of a Substation grounding grid design in line with IEEE STD80-2000 standard. A comparison of the results obtained using the two algorithms give the information on the best technique in terms of Step and Touch voltages. Ground Potential Rise (GPR) and Ground Resistance R_g for the proposed siting of the substation. The simulation was done in MATLAB R2015b. A design evaluation obtained by applying HSA and GA shows performances that are superior to those of IEEE STD80-2000. The maximum touch voltages are 814.70V and 812.77V for HSA and GA respectively. These values are superior to a maximum touch voltage of 758.21V obtained by applying the IEEE STD 80-2000. The maximum step voltages obtained are 283.77V and 308.48V for HSA and GA respectively against the IEEE STD80-2000 value of 392.91V. The step voltage reduced by 8.7% when its value obtained by applying HSA is compared to that obtained by applying GA. These results show that HSA outperformed GA as it reduces the maximum step voltage thus increasing the safety level. Furthermore, the GPR and the grid resistance values obtained using HSA showed remarkable reduction of 3.44%.

INTRODUCTION

Today, more and more substations are created and reconstructed to satisfy the growing electricity demands for both industry and households (Wu et al., 2016). As a result, an adequate grounding system is needed to protect people from dangerous touch and step potentials. Therefore, step and touch voltage at any point of the installation should not exceed the maximum allowable values (Wu et al., 2016). The purpose of grounding circuit is to provide a path for the fault currents enabling protection circuit to take necessary action (Kara et al., 2016). Performance of a grounding grid depends on the soil structure and grid configuration. Ground grid can have equally or

unequally spaced conductors with or without ground rods. Soil may be uniform, two layer or multilayer (Perng & Kuo, 2018). Various optimization techniques have been used in literature to design the grounding grid of substation. (Id et al., 2021) designed a digital application for grounding grid calculations of substations aimed at reducing the complexity and time of design. (Alik et al., 2015) minimized the problem of a cost function depending on the large number of parameters when designing grounding grid of substation using PSO, GA and a hybrid of PSO and GA. (Bonda & Mishra, 2018) presented an optimized design of earthing system for a substation located in high soil resistivity with limited plot using computer

design program. (Id et al., 2021) worked on features and cost optimizations of grounding grids in various soil conditions (i.e. uniform soil, two-layer horizontal soil, and two-layer vertical soil) using Simulated annealing and Current Distribution, Electromagnetic Fields, Grounding And Soil Structure Analysis(CDEGS). (Kara et al., 2016) designed an optimum grounding grid using GA. (Lei et al., 2012) designed an Optimal Substation Grounding Grid based on Genetic Algorithm Technique. (Wu et al., 2016) developed a software for an optimal substation ground grid design based on Genetic Algorithm and Pattern Search. This paper seeks to evaluate an optimal design of substation grounding grids by minimizing the step and touch voltages, the length of grounding grids and number of grounding rods using Harmony Search Algorithm, with a view to reducing the overall cost of procurement and installation of the grounding grids.

Grounding Grid

Grounding grid is an arrangement in an electrical substation, plant or system which is related to the protection of people and equipment and/or the optimal operation of the system involved (Zhang, 2014). The term "Grounding" is a method of providing a good electrical connection between metallic structures or electrical circuits and a metallic system buried in the earth. This is done with the aim of maintaining such structures at the general electrical potential of the earth (i.e. zero potential) or at the same potential with the earth, thus preventing undesirable and dangerous potential differences (Smestad et al., 2020)

Ground Potential Rise (GPR)

The objective function is as stated in equation (3)

The performance and safety of any power substation is mainly dependent on the ability of the grounding grid to provide a robust GPR occurs when a large current flow to earth through an earth grid impedance. It is caused by electrical faults that occur at electrical substations (Kapijan, 2017). Since the resistance of the earth is non-zero, a current injected into the ground produces a potential rise (EI-Fergany, 2013). GPR therefore is the maximum electrical potential a grounding grid may attain relative to a distant grounding point assumed to be at the potential of remote earth (EI-Fergany, 2013). GPR is proportional to both the current flowing in the ground grid and the equivalent grid impedance and is presented mathematically as (EI-Fergany, 2013):

Harmony Search Algorithm (HSA)

In the basic Harmony Search Algorithm, the music improvisation is a process of searching for a better harmony by trying various combinations of pitches that should follow any of the following three rules (Id et al., 2021). The rules are, choosing any value from the HS memory, choosing an adjacent value from the HS memory and choosing a random value from the possible value range. The three rules in the HSA are effectively directed using two essential parameters: harmony memory considering rate (HMCR) and pitch adjusting rate (PAR) (Uma et al., 2016).

For an n-dimension problem, an Harmony Memory (HM) of a particular Harmony Memory Size (HMS) can be represented as follows (Nasir et al., 2020):

are guaranteed in accordance to IEEE standard (Bhatia et al., 2020). The objective function is aimed at minimising such dangerous potentials vis a vis ground resistance R_g Ground potential rise. Step and touch voltages values that may arise during such fault. Minimization of the above parameters result in the reduction of the length and configuration of the conductor grids grounding and the grounding rods for the particular soil characteristics. This invariably

has a great significance on the cost of implementation when siting power substation in a particular location. Equation 3 depicts the cost optimisation in terms of the Area of the substation, the length of the grid in the X and Y axis and number of grounding rods needed to achieve the IEEE safety standard. Equation 4 to 6 are the constraints parameters to achieve the safety level desired.

Step voltage

Step voltage is the voltage between the feet of a person standing near an energized grounded object (Jambak et al., 2017). To evaluate the allowable step voltage, the equation relating to person weighing 50 kg/70kg is provided as:

From (9), the correction factor is dependent on the depth and resistivity of the surface material and the resistivity of the soil layer underneath the surface material.

Touch voltage

Touch voltage is the voltage between an energized object and the feet of a person in contact with the energized object (Jambak et al., 2017). This is also stated that the allowable touch voltage for a person weighing 50 kg/ 70kg respectively is given as (Kapijan, 2017):

From (9) and (10), if the fault duration is made constant and the resistivity of the surface material is increased, a greater GPR may be present in substation without causing any hazardous effects (Ackerman, A., Sen, P. K., and Oertli, 2013)

METHODOLOGY

Measurement and collection of data for soil resistivity was carried out on Kubwa expressway in Abuja. The measurement was carried out on every grid of 10m x 10m spacing. Also, 4 sets of apparent resistivity readings were obtained for the probe spacing of 1.5m, 2.0m, 3.0m and 4.5m corresponding to the depth of measurement. The readings obtained gave different values of apparent resistivity at each depth. The thickness of each depth has corresponding resistivity value from one layer to the other. This test was repeated throughout the entire grid of 70m x 70m on site. Plate 1 shows the apparent resistivity reading in progress, while Plate 2 shows the test measurement on site as well.

Based on the measurement and characteristics of the soil, the apparent resistivity measurement was carried out at a distance of 0.5m and 1.5m to 4.5m between the Megger DET2/2 Testing equipment probes. This corresponded to the apparent resistivity values read off by the equipment at such depth.

Table 1 shows the measured apparent resistivity data. The measured values of the apparent ground resistivity from the selected site were used as data input to calculate for standard metrics for the design, using (11) – (14) according to IEEE STD80-2000 manuals for substation grounding design.

3.1 Estimation of maximum allowable (rate) touch voltage, step voltage, and ground potential rise suggested by the ANSI/IEEE STD80-2000

In order to find the ground grid resistance, maximum grid current and ground potential rise to make an estimation, (11) - (14) were used. They were determined so that the step and touch voltages could be computed from equations (9) – (10). The mesh voltage is dependent on the length of the copper conductor, grid arrangement in horizontal-vertical axis and the number of grounding rods on the site. The mesh voltage is determined as follows;

Based on Equations (17) to (19), preliminary estimation of the conductor loop, number of rods and locations was performed. The initial estimates of conductor spacing based on the current I_G was also specified. The preliminary resistance of the grounding system in uniform soil was determined as follows;

Where R_1 is the preliminary ground resistance in uniform soil model and is dependent on the average apparent soil resistivity from the site.

Performance evaluation

Certain metrics are used to evaluate the performance of the proposed design. These metrics include GPR, step voltage and touch voltage. The optimal results obtained by applying HSA and GA were compared to those obtained using IEEE STD80 2000 measurement.

RESULT AND DISCUSSION

The result in Figure 3 is a graphical representation of Grid Layout including the grounding rod points for IEEE80-2000 standard guide. The result was generated from the set of codes including equations (11)-(19) ran on MATLAB R2015b using GA and HSA with a view to meeting the touch potential criterion for safety.

In the grid spacing, the touch voltage profile is more even for the IEEE generating 10 x 10 meshes with 20 grounding rods at the outer grids line as depicted in Figure 1, while Figure 2 depicts the touch voltage profile on the earth's surface computed along the main diagonal. Table 2 shows the Touch (E_{touch}) and Maximum touch voltages as 840.548V and 758.208V



It also showed a tremendous reduction in the length of the grid and number of grounding rods compared to IEEE std 80-2000. The dot point on the grid layout indicates the grounding rods positions. HSA also returned 2 x 2meshes of an even and equally spaced grids with 4 grounding rods on the outermost grids as shown in Figure 4. A 3-dimensional view of the grid arrangement and their associated

respectively while the maximum step voltage is 392.9076V. Figure 3 shows the generated grid/grounding rods layouts as obtained from the output of the Genetic Algorithm. The grid layout is an uneven grid with meshes of 3 x 4 along vertical and horizontal axis with 2 grounding rods each at the upper and lower outer grids.



grounding rods is as shown in Figure 5 and Figure 6 for GA and HSA. It can be seen that the total length of grounding grids is longer for the GA with fewer grounding rods (i.e. 4) while the grid length is shorter for HSA with an increase in the grounding rods (i.e. 16). Figure 7 and 8 depicts the Touch potential waveform along the diagonal of the grids as generated by GA and HSA.

Table 2 gives the performance evaluation of the two algorithms compared with IEEESTD80-2000 for the selected site. The maximum E_{touch} voltages waveform along the

grid diagonals are 812.77V for GA and 814.70V for HSA respectively. HSA outperforms GA in this case by 0.236%.

The maximum touch for IEEE was 758.21V against GA value of 812.77V and HSA value of 814.70V representing 0.236 %

improvement in maximum Touch voltage over GA. The step voltage for IEEE was 392.91V. GA gave a value of 308.48V while HSA returned a

reduced value of 283.77V representing 8.71% reduction when compared with the value from GA. Also, both the GPR and the Grid resistance computed using IEAE STD 80-2000. Both GA and HSA returned values that give better performance when compared with IEEE STD 80-2000 base case values. Table 3 gives the performance evaluation of HSA over GA in terms of Step voltages, Ground potential rise, the grid resistance and maximum touch potential. The performances shown by both GA and HSA arose from the reduction in the overall

grid resistances obtained due to the configurations returned by the two optimisation techniques. Since the dangerous fault current flows out to the earth through the least resistive path created by grid conductors/grounding rods positions, the GPR, step and touch voltages are also reduced through a lower grid resistance. Of significant importance is the reduction in the length of the grid conductors from the HSA that brought about 8.708% reduction in the step voltage and the GPR reduced by 3.441% from the GA values.

CONCLUSION

An optimal design of substation grounding grids with two soil layer method has been evaluated in this paper. The touch and step voltages, ground potential rise and ground resistance of a site located in Kubwa expressway, Abuja have been determined by applying three different methods which are the IEEE STD80-2000, GA and HSA with a view to minimizing the GPR. step and touch voltages. The performance of HSA was compared with those of GA and IEEE STD80-2000 standard. The algorithms were implemented in MATLAB R2015b. From the analysis and evaluation, it was observed that the selected site was suitable for the construction/siting of the proposed substation and that a cost-effective installation is achievable for this location.
