



Smart Monitoring System Development for Solar Box Cookers using IoT Technology

ABSTRACT

The successful implementation of an internet of things (IoT) based monitoring interface has significantly enhanced the solar box cooker's functionality and usability. By integrating cutting-edge technologies like Arduino UNO, MTCBA-G-F1/F2 module, thermal sensors, and a buzzer, this initiative transform the conventional cooker into an intelligent, user-friendly device. Real-world testing at the Centre of Entrepreneurship and Enterprises Development in northeastern Nigeria validated the interface's seamless operation within the cooker's context, ensuring both technical prowess and practical reliability. These tests confirmed the system's potential to revolutionize the traditional solar box cooker, making it smarter, more efficient, and user-centric.

INTRODUCTION

Cooking, an essential daily activity for sustenance heavily relies on various energy sources worldwide, spanning fossil fuels, firewood, and charcoal. However, rising costs of traditional fuels like cooking gas and fossil resources, coupled with erratic power supplies, particularly prevalent in developing regions have led many rural and urban dwellers to predominantly use firewood for cooking (Komolafe and Awogbemi, 2010).

The combustion of firewood, charcoal, and agricultural remnants, alongside slash-andburn agricultural methods, significantly contributes to global carbon emissions, accounting for a substantial 5%–20% Smith et al., (1993). This heightened environmental impact has sparked a global awareness among energy experts about the adverse effects of nonenvironmentally friendly fuels on the planet, particularly their role in exacerbating global warming.

In response to these environmental concerns, there's a growing momentum towards tapping into renewable energy sources, particularly the abundant and eco-friendly energy provided by the sun. Utilizing solar energy for cooking has emerged as a compelling alternative due to its inherent cleanliness, safety, and widespread availability. Embracing this sustainable energy source offers a promising solution to mitigate the detrimental environmental effects linked to traditional cooking fuels. This shift signifies a conscientious effort to adopt cleaner and more sustainable cooking practices to safeguard the environment.

Comprising an insulated box with reflective panels, a transparent cover (often glass or plastic), and a darkened cooking chamber, this cooker capitalizes on fundamental principles of physics to create a self-contained, solar-powered oven.

The basic premise underlying the functionality of solar box cookers hinges on the greenhouse effect. Transparent materials, such as glass or plastic, allow sunlight to pass through and trap the radiant energy inside the box. Once inside, this energy is absorbed by the dark interior surfaces, heating the air within the enclosure. The insulation prevents heat loss, creating a consistently warm environment suitable for cooking various types of food.

The versatility of solar box cookers is a key feature that distinguishes them. Their ability to achieve and maintain moderate temperatures makes them adaptable to different cooking styles, from slow-cooking stews and soups to baking bread and pastries. Furthermore, their relatively simple construction using readily available materials and their ease of use make them accessible to a wide range of communities, especially in areas where access to conventional cooking fuels is limited or where their cost is prohibitive.

While solar box cookers offer a sustainable and eco-friendly alternative to traditional cooking methods, their efficiency can be influenced by a multitude of factors. Geographic location, prevailing weather conditions, seasonal variations, and cultural acceptance all play roles in determining their effectiveness. However, ongoing advancements in design, materials, and optimization techniques continually improve their performance and broaden their applicability across diverse regions and climates.

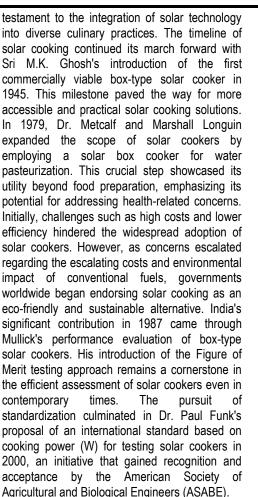
Tschirnhausen, a German physicist, emerged as an early trailblazer in the realm of solar cooking. His pioneering experiments involved utilizing the sun's rays to heat a clay pot, achieving the remarkable feat of boiling water through the focused concentration of sunlight using a sizable lens-an inventive leap into the potential of solar energy for culinary applications. Horace de Saussure, a Swiss geologist and physicist, marked a significant milestone in 1767 by crafting the first documented solar cooker. His creation, essentially a solar collector. demonstrated the capability to reach temperatures of up to 88°C, laying the foundation for harnessing the sun's energy for cooking purposes. The progression of solar cooking continued across time and geography. manifesting in various forms and designs. Sir John Herschel, during his expedition in South Africa in 1830, introduced an insulated solar cooker to prepare meals, showcasing the adaptability and utility of solar cooking methods even in diverse climates and terrains. A pivotal leap forward came in 1869 with Mouchot's innovative development of the parabolic solar cooker. This groundbreaking design innovation not only enhanced efficiency but also found practical application when Napolean III deployed it for French Colonial troops in Africa, highlighting its relevance in real-world scenarios. India made its mark in the narrative of solar cooking with W. Adams' creation of the first panel solar cooker in 1876. This ingenious solar oven, comprising eight reflecting mirrors, efficiently cooked vegetables and meat, demonstrating its practicality by preparing meals for seven soldiers within a mere two hours-a remarkable feat for its time. Even culinary traditions found a place in the evolving saga of solar cooking. In 1894, Xiao's Duck Shop in Sichuan. China. gained fame for roasting ducks using a solar cooker a

In order to make cooking more effective, solar cookers are incorporated with phase

change materials (PCMs), that enhances the cooking time period. The PCMs convert their forms from solid to liquid and liquid to solid either releasing or absorbing heat. Heat is absorbed by solid PCMs results in changing their phase from solid to liquid and heat is released by such PCMs when the temperature drops after regaining their shape. (Safdar et al., 2022). Cuce (2018), used Bayburt stone, a beige tuff quarried in Bayburt, Turkey. He compared two identical cookers, one filled with stones and the other without them, Coccia *et al.* (2018) tested high concentration ratio box cooker provided with a thermal storage

unit. The PCM consisted of a 4 kg mixture comprising KNO3, NaNO2 and NaNO3 (melting temperature of 145°C and latent heat of fusion 101.5 kJ/kg) and was included in a double walled pot, maina et al., (2019), experiment stearic acid for solar thermal energy storage in a double compartment solar box cooker.

Generally, the integration of tracking methods significantly enhances the performance, efficiency, and reliability of solar cookers, making them more effective and practical for daily cooking needs while promoting sustainable energy usage. The use of tracking methods in solar cookers offers several significant benefits that enhance their efficiency and effectiveness in harnessing solar energy for cooking purposes. Tracking methods for solar cookers involve different approaches and technologies used to follow the sun's path and maximize its utilization for cooking purposes. These methods aim to optimize the absorption of solar energy and maintain the cooker's alignment with the sun's position throughout the day. Here's an overview of various tracking methods and their types solar trackers based on number of axis and type of drive in solar tracking. Each tracking method has its advantages and limitations. Passive cookers are simple and cost-effective but might not capture maximum sunlight. Active systems offer better efficiency but might be more complex and expensive to implement. The choice of tracking method often depends on factors such as cost, complexity, cooking efficiency, and the user's preference or available resources. (Gokul et al., 2021). Mahmud et al., (2023), carried out A Design and Fabrication of an Automated Solar Energy Tracker Integrated Four-Sided Reflector-Based Box-Type Solar Cooker to Increase Efficiency by Absorbing Maximum Solar Energy, Abdulrahim et al., (2015) development of an automated tracker for the enhancement of energy availability in a solar box oven, Prodhan et al., (2016). Designed and constructed an automatic solar tracker and carried out performance evaluation. Nehra and Sanjeev (2015), have developed a sun tracking system for solar cooker. Clement and Clinton. (2022),

- 2. 4 LM35 precision centigrade sensors
- 3. LCD 016N002b-CFU display
- 4. GSM module for SMS notifications
- 5. ABI 009-RC buzzers

Battery-based power supply with on/off switch Arduino Uno is a microcontroller board based on Atmega328p which allows you to program the Arduino in order for it to be able to execute commands and make decisions based on various inputs. It has14 digital input/output pins as shown in plate 1.1.

GSM AT Commands

Plate 1.2 depicts the MTCBA-G-F1/F2 is commands which are used to control the MODEMs where AT stands for Attention. The AT commands can be used with GSM and GPES,

MODEMs or Phone to access these services and information sms, mms, fax, voice link and other data over mobile network, information and configuration concerning the mobile devise or MODEMs and SIM card.

LM35 Precision Centigrade Temperature Sensors

The LM35 series are precision integrated-circuit temperature devices with an output voltage linearly proportional to the Centigrade temperature. The LM35 device has an advantage over linear temperature sensors calibrated in Kelvin, as the user is not required to subtract a large constant voltage from the output to obtain convenient Centigrade scaling. The low output impedance, linear output, and precise inherent calibration of the LM35 device makes interfacing to readout or control circuitry especially easy. 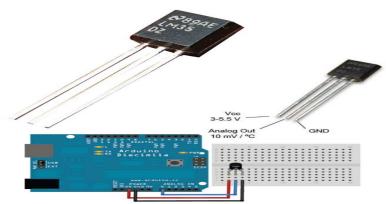


Plate1.3: LM35 Precision Centigrade Temperature Sensors

LCD-016N002B-CFH-ET

The LCD display Module is built in a LSI controller, the controller has two 8-bit registers, an instruction register (IR) and a data register (DR). As seen in plate: 1.4. The IR stores instruction codes, such as display clear and

cursor shift, and address information for display data RAM (DDRAM) and character generator (CGRAM). The IR can only be written from the MPU. The DR temporarily stores data to be written or read from DDRAM or CGRAM. When address information is written into the IR, then

data is stored into the DR from DDRAM or CGRAM. By the register selector (RS) signal, these two registers can be selected.

Buzzer

Buzzer (ABI-009-RC) is an active buzzer module useful for creating sound in a project. Shown in plate: 1.5. The drive circuitry built into it, so a simple active HIGH LOGIC LEVEL SIGNAL will activate the buzzer. Though simple to use, the downside of the active buzzer

is fixed at a particular frequency and the loudness is more or less fixed. These are mainly useful for signaling or an alarm. It is moderately loud at about85dB with a 2.3 kHz frequency, so it be best suitable for use as an attention getting alarm or beeper.

System Functionality

1. Temperature Sensing and Display:

- Continuous monitoring of absorber plate, oven, water, and ambient temperatures.
- Displaying real-time temperature values on the LCD.
- 2. SMS Notifications:
 - Sending SMS alerts to the user's phone:
 - "Cooker warm" when the oven temperature reaches 45°C.
 - "Almost Ready" when the water temperature hits 75°C.
 - "Ready" when the water temperature reaches 100°C.
- 3. Alarm System:
 - Activating the ABI 009-RC buzzers simultaneously with SMS notifications for the specified temperature thresholds.

4. Power Management:

 Utilizing a battery-based power supply with an on/off





switch for easy control of the system.

Working of proposed IoT interface for Solar Box Cooker

The interface developed for overseeing the Solar Box Cooker (SBC) is an intricate system utilizing Arduino UNO, a **GSM AT Commands** MTCBA-G-F1/F2, and thermal sensors for efficient monitoring and control. Using an Arduino UNO in tandem with the **GSM AT Commands** MTCBA-G-F1/F2, along with the Node MCU serving as the WiFi module's platform, this interface allows for seamless connectivity. The system employs LM35 and PT100 temperature sensors to measure both the ambient temperature and the temperature within the box cooker, respectively.

The Arduino UNO serves as the primary processing unit, gathering data from these sensors to calculate the optimal proxessing time. The GSM AT Commands

MTCBA-G-F1/F2 plays a critical role in establishing a secure communication channel between the Arduino processor, user phone and

buzzer. To enable real-time monitoring, essential metrics such as ambient temperature, absorber plate temperature water temperature and oven temperature of the box cooker, are continually displayed. This information is visible on an LCD screen. Upon reaching the specified oven temperature, water temperature and completion of the boiling process, the system promptly sends simultaneous notification to the user via The GSM Commands MTCBA-G-F1/F2 AT application to the user phone and alarm via buzzer, simplifying the monitoring process for the Solar Box Cooker.

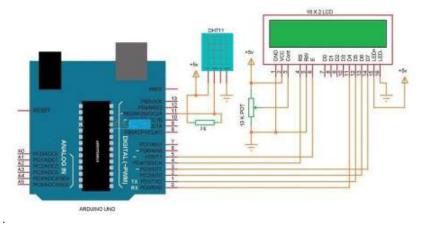


figure 3.1: circuit diagram of Arduino uno with LCD

The entire system is powered by a DC battery, ensuring a sustainable and consistent energy source. This battery acts as an energy reservoir, enabling continuous operation of the system. In summary, this robust IoT interface optimizes the supervision and control of the Solar Box Cooker by integrating temperature monitoring, real-time data visualization, remote notifications, and a reliable power supply system DC battery, as depicted by the circuit diagram in figure 3.1 and figure 3.2.

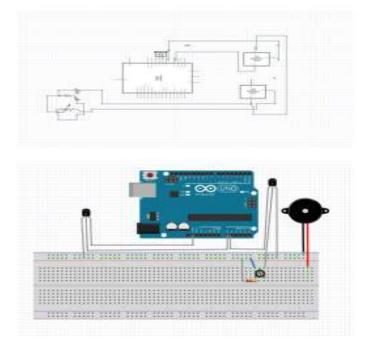


figure 3.1: circuit diagram of Arduino uno with Buzzer.

entrepreneurship and Enterprises Development University of Maiduguri, Borno state. plate 4.1 showcases the smart system before coupling.

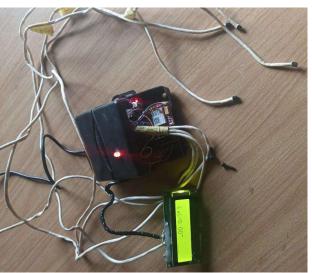


Plate 4.1: Smart monitoring system with IoT interface before coupling

By enabling remote monitoring, the interface effectively minimized heat loss, thereby streamlining the boiling process and reducing boiling times. The smart solar box cooker system ensures precise temperature monitoring, user alerts, and safety measures, enhancing the water boiling experience while promoting energy efficiency and sustainability.

The successful development and implementation of an IoT-based monitoring interface mark a significant stride in enhancing the functionality and usability of a specific model of solar box cooker, measuring 500 X 400 X 300 mm. This endeavor has been a culmination of integrating cutting-edge technologies, including

Arduino UNO, MTCBA-G-F1/F2 module, thermal sensors and buzzer, aimed at transforming the traditional cooker into an intelligent and user-friendly device.
