The successful incorporation of social media platforms as complaint channels exemplifies an innovative approach to collecting and addressing feedback in the digital era. The research provides essential view for software developers and organizations seeking to enhance their complaint management systems. It highlights the paramount importance of user-centric design, social media integration, and stringent security measures. The study's implications extend to stakeholders, including researchers, practitioners, and organizations, offering actionable insights into improving complaint management procedures, elevating user experiences, and fostering heightened customer satisfaction. The recommendations emphasize scalability planning, administrator training, and a continuous improvement mindset. Future studies are suggested to explore security and compliance frameworks, scalability optimization, and integration with Customer Relationship Management (CRM) systems. Overall, this study contributes significantly to advancing complaint management practices in the digital age, aligning them with contemporary trends and technology-driven solutions.

The ways in which customers express, share, and discuss their complaints differ based on whether they made their purchases offline or online (Chang et al., 2021). Notably, the volume of customer complaints is higher in the area of online business compared to traditional business areas. With the arrival of the technological era, customers now have access to new channels through which they can communicate, discuss, express, and share their dissatisfaction and unfavorable experiences through social media platforms (Peeroo, 2017).

Therefore, when these complaints are made on social media platforms, the negative comments and responses can easily and quickly spread to a wide audience, possibly causing serious harm to the reputations of organizations and institutions (Melancon & Dalakas 2022). This emphasizes the significance of excellent service recovery in today's increasingly complicated multichannel retail market. Existing systems lack or fail to effectively address customer complaints. especially those that involve third parties. So far, only a small number of complaints have been taken into consideration, disregarding or ignoring the impression of the numerous customer needs. In the study of Mary et al. (2020), the study focused on voicing out complaints to the organizations only, where there are other complaint options such as exit or complaining to third parties.

Aim and Objectives of the Study

However, these studies have shortcomings, such as a lack of precision in issues such as identifying and computing measures, ignoring complaint channels and shopper categories, and failing to examine new complaint channels or social media platform differentiation. Overall, these studies provide important insights into complaint management systems, but they also point to areas that need further investigation and development. Therefore, this study intends to develop a social media complaint management system that captures third-party engagement for the Eco Bank Bauchi main branch.

Gaps model of service quality

The GAPs Model of Service Quality, developed by Parasuraman and Michel (2019), is a valuable model that offers managers tools to help improve the service quality levels provided by companies that provide services. (Zeithaml, 2020) explained that the GAPs Model provides insights into potential gaps, which then influence consumers' perceptions of the quality of service obtained throughout service delivery. The model is built around five gaps (Zeithaml, 2020; Boshoff & Du, 2019; Srinivasan, 2019):

- 1. Listening Gap: the gap between customers' service expectations and service institutions' perceptions of these expectations
- 2. Service Design and Standard Gap: the gap between management's knowledge of customer expectations and the development of service designs and standards.
- 3. Service Performance Gap: the difference between developing customer-driven service standards and actual service performance by workers
- 4. **Communication Gap:** the gap between the service offered to consumers and the essential information about that service; and
- 5. **Consumer Gap:** the gap between customer expectations and service perception, this gap is defined by the size and direction of the four gaps connected with service quality delivery on the marketer's side

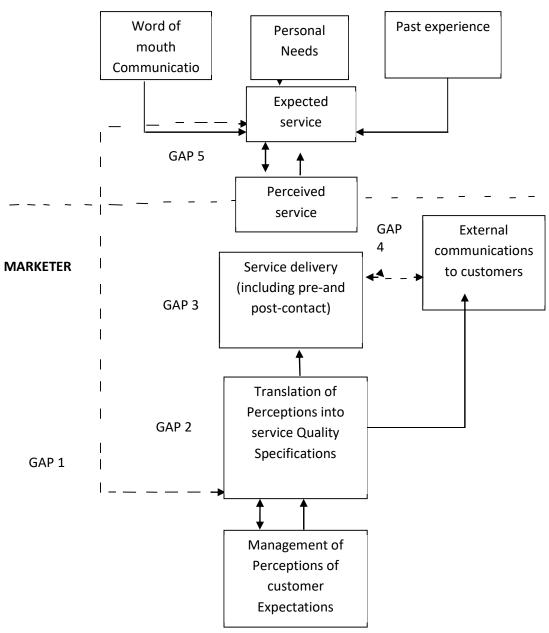


Figure 1: Gaps Analysis Model. (Source: Zeithaml, 2020)

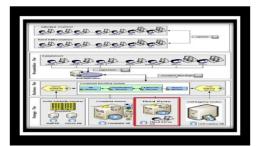


Figure 2: Proposed Framework

for establishing data relationships and defining how information flows throughout the system.

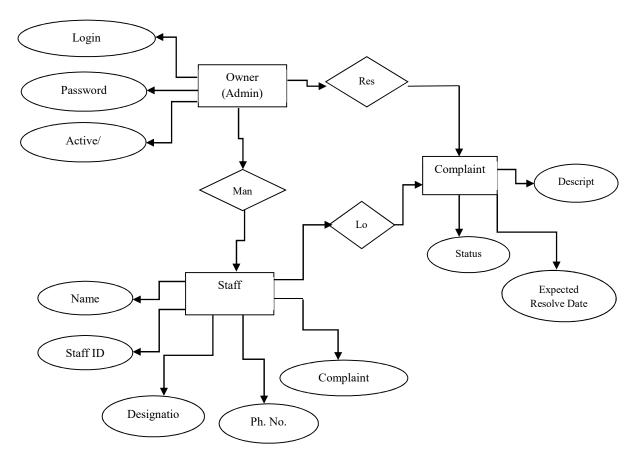


Figure 3: Entity-Relationship (ER) Diagram

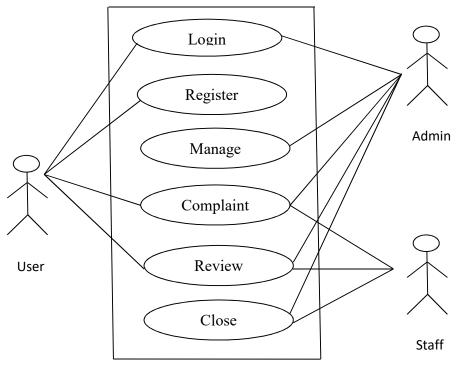


Figure 4: Use Case Diagram

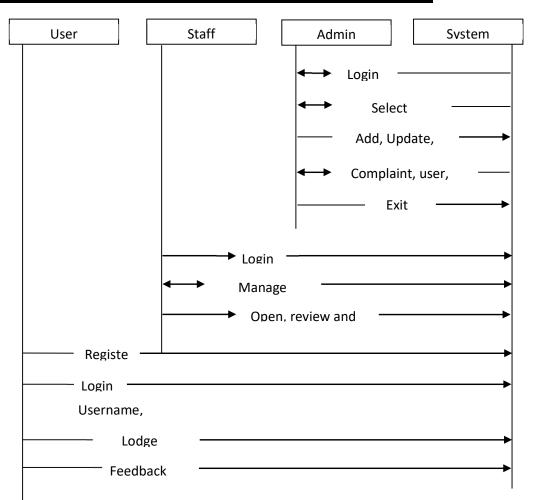


Figure 5: Sequence Diagram

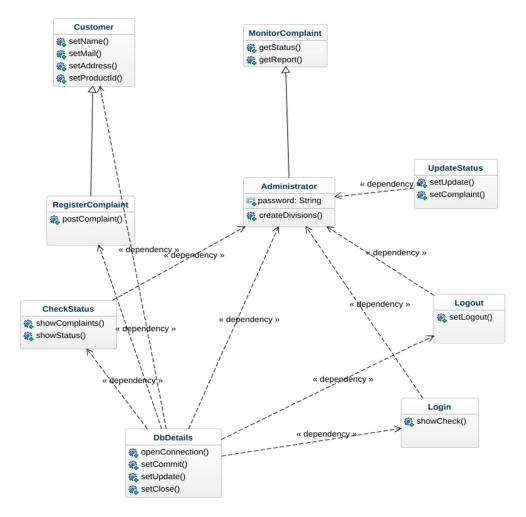


Figure 6: Class Diagram

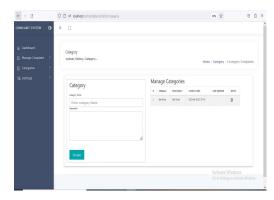


Figure 11: Category page

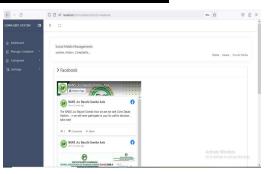


Figure 12: social media page

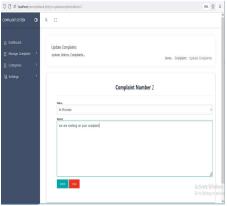


Figure 13: complaint update page
