



## The Influence of Teachers' Effectiveness and Motivation for Teaching English Language in Bauchi Metropolis

### ABSTRACT

*This study investigates the impact of teacher effectiveness and motivation on the teaching of English language in Bauchi metropolis. The research focuses on the crucial role educators' play in enhancing students' linguistic competence and explores the relationship between teacher qualities and students' proficiency levels in English. Using a quasi-experimental design, the study collected pre-test and post-test data from selected Senior Secondary Schools in Bauchi state, specifically Government Day Senior Secondary School Kofar Wambai. The target population comprised SS2 students, totaling 911. The findings revealed that there was no significant difference between the control and experimental groups, suggesting that both groups had similar scores. However, students who received reading fluency treatment performed better in essay writing, including idea presentation, word choice, and relevance. The study concludes that teaching reading fluency significantly affected students' written performances, enhancing their ability to think, organize thoughts sequentially, and write creatively with fewer grammatical errors. Recommendations include implementing reading fluency strategies in teaching to improve writing among senior secondary school students and incorporating reading fluency into the secondary school English curriculum. This approach aims to not only assess students' comprehension but also enhance their reading speed, accuracy, and rate.*

#### Herzberg's Two Factor Theory

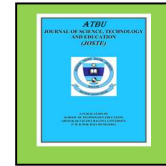

Surveys were distributed to English language teachers in Bauchi metropolis to collect data on teacher effectiveness, motivation levels, teaching strategies, and

The given scenario involves a population of 1554 English language teachers in Bauchi metropolis, spanning across 22 senior secondary schools. From this population, a sample of 400 teachers were randomly selected for the study. The selected sample will represent

a diverse group of English language educators, providing valuable insights into teacher effectiveness and motivation in teaching the language. The 400 teachers selected from the five schools will offer a representative sample of the larger population, enabling researchers to draw meaningful conclusions based on the collected. For the research study on the influence of teacher effectiveness and motivation for teaching English language in Bauchi metropolis, the following research instruments were utilized: A structured survey questionnaire was designed to gather quantitative data on teacher effectiveness, motivation levels, teaching strategies, and perceived student outcomes. This instrument will include Likert scale questions, multiple-choice questions, and open-ended questions to capture a range of responses.

The population for the project on the influence of teacher effectiveness and motivation for teaching English language in Bauchi metropolis includes all English language teachers working in schools, colleges, and educational institutions within the geographic area of Bauchi metropolis. This encompasses a diverse group of educators involved in teaching English language to students at various levels, from primary to tertiary education. The population consists of both experienced teachers and those who are relatively new to the profession, offering a comprehensive view of the teacher demographics influencing teaching English. The research design for studying teacher effectiveness and motivation for teaching English language in Bauchi metropolis will employ a mixed-methods approach. This approach combines quantitative surveys and qualitative interviews to gather comprehensive data on the subject.

The standard deviation ranges from 0.59 – 1.03 indicating that the respondents were

not far from each other in their opinions. With a grand mean and standard deviation of 2.46 and 0.82 respectively, Table 6 indicated that there is some effective teachers to teach c English in terms of subject matter.

Items 1, 3 and 4 recorded mean scores ranging from 1.89 to 2.32 indicating slightly possessed while items 2 and 5 recorded mean scores ranging from 2.52 to 2.56 indicating moderately possessed. Standard deviation ranges from 0.42 to 1.11 indicating that the respondents were not far

from each other in their opinions. With a grand mean of 2.28 and a standard deviation of 0.87, Table 8 indicated that there is a significantly relationship between motivation and performance of teachers.

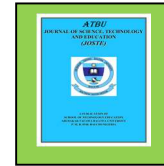

Standard deviation ranges from 0.71 1.03 indicating that the respondents were not far from each other in their opinions. With a grand mean of 2.74 and a standard deviation of 0.86, Table 3 indicated that there is a significant relationship between use of

**Decision**

Since  $\chi^2$  tabulated 16.919 is less than  $\chi^2$  calculated 29.840 alternative hypotheses ( $H_1$ ) accepted which state that There is significantly relationship between use of motivational strategies and English teachers' performance in secondary school English."

**DISCUSSION OF FINDINGS**

The finding of the data analyzed reveals that the respondents agreed that status of the student, demonstration teaching method has positive effects in enhancing learning outcomes. This discovery therefore showed that both male and female students when exposed to the treatment of demonstration teaching method perform well in their academic mean scores implying that both male and female derive almost equal benefit from being taught using the demonstration teaching method. This is particularly instructive because a number of teacher instructional strategy tends to be gender bias in favour or against a particular sex. For example, Lawal (2009) explained that female subjects were significantly better than their male counterparts and that there was a significant difference between the male and female subjects in their ability to solve quantitative problems.

Jegede (2010) and Omwrhiren (2002) observed that male subjects were significantly better than their female counterparts. However, Muhammad (2014) and Opara and Waswa (2013) in their separate studies saw no significant difference in achievement between gender. This

implies that the use of demonstration. method is good for both boys and girls. Odunbunmi and Onafowokan (2003), observed no difference in performance based on gender when the subjects were taught using Hands-on experience method of teaching basic science at junior secondary school level. Bichi (2002), revealed that there was no significant difference in the performance of both male and female students in the study on Effects of problem solving strategy and enriching curriculum on senior secondary school students' achievement in evolution concepts using problem solving instructional method.

The findings of this study have implications for chemistry and science teaching in Nigeria secondary schools. The persistent failure of students in chemistry could be arrested if teachers were better equipped with effective strategies such as the demonstration instructional strategy. The researchers advocate that teachers should not only be seen as agents of knowledge transmission but also that of alienating or transferring ownership of learning to their students. Classroom lessons and environment should be organized in such a way as to elicit learners' potential to think creatively, participate actively and reflectively.

Chemistry has suffered great negligence in many private and public schools due to the above factors. A situation where a chemistry teacher is devoid of the knowledge and skill to manipulate the laboratory equipment or even a worst scenario, when the equipment are not available and are not even improvised by the

teacher, the practical aspect of chemistry is simply ignored. Eze (2001) seem to support the above findings when he reported that physical facilities such as classroom, laboratories are abysmally inadequate, unmaintained and lack requisite apparatus and equipment. The abundance of materials and equipment for teaching and learning of chemistry practicals may not be enough to bring about better performance of the students without a competent chemistry teacher. According to Ali (2001), these materials will hardly be helpful if the teacher does not use them effectively and efficiently. In table 2 the result of the data analyzed showed that some of the students factors that affect the teaching of practical include that: most students perceive English as a difficult subject with many theories, discouragement faced by students at the poor outcome of their results, sudden loss of interest in English, inconsistency in attendance of English practical class and lack of mathematical proficiency in practical chemistry calculations.

English students are usually faced with these challenges and this impacts serious negative perception and phobia in their understanding and practice of English practical. However, the above findings are in agreement with the assertion of Olotu (1999) where he observed that in some secondary schools in Nigeria where basic principles of science are taught in preparation for further education, many students are not interested in the practical aspect of science but the theoretical aspects. He further said that students had to be persuaded to attend practical classes. In connection to this, Amaefule (2001) reported that many students perceive English as a difficult subject because of its many theories which prove difficult to comprehend by some students. Also in support of this findings, Obande (2003) however, opined that the fear of mathematics is often transferred to English which involves one form of calculation or the other.

## CONCLUSION

The study on teacher effectiveness and motivation for teaching English language in Bauchi metropolis revealed significant insights into the crucial role educators play in enhancing

students' language proficiency. The research highlighted the positive correlation between teacher effectiveness, motivation, and student outcomes, emphasizing the importance of knowledgeable, engaged, and motivated teachers in fostering linguistic competence among learners. Strategies employed by effective and motivated teachers were found to enhance student engagement, participation, and overall learning experiences in English language classrooms.

## RECOMMENDATIONS

1. Professional Development Programs: Educational authorities and institutions should provide continuous professional development opportunities for English language teachers in Bauchi metropolis to enhance their teaching skills, content knowledge, and motivation levels.
2. Recognition and Incentives: Recognizing and rewarding effective and motivated teachers can serve as a source of encouragement and motivation. Incentive programs based on performance can further motivate teachers to improve their teaching practices.
3. Peer Collaboration: Encouraging collaborative learning among

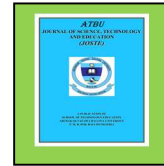
