The English Curriculum is designed with the four language skills integrated in the content. Topics are arranged around the skills which are listening, speaking, reading and writing, grammatical accuracy and literature. The prescription of the Curriculum includes the performance objectives; themes, content. activities for the teachers and learners, teaching and learning materials and guides for assessment. This prescription reveals the expected content to be taught in the class so as to achieve the objectives the Curriculum is designed for Onatere, Isama and Okpan (2021). Over time the Nigeria's educational system has not met the longings and aspirations of the Nigerian people. School Environment

The overall atmosphere and culture of the school can either support or impede curriculum implementation. Factors such as school leadership, support systems, and disciplinary policies can influence teachers' capacity to implement the curriculum (Garcia & Martinez, 2018).

Instructional Supervision and Assessment

Effective supervision and assessment practices are crucial for ensuring that curriculum goals are being met. Inadequate supervision and assessment strategies can undermine teachers' efforts in implementing the curriculum and assessing student progress (Wang & Smith, 2017).

Readiness and Knowledge of Teachers Teacher Attitudes

Teachers' attitudes towards curriculum implementation can significantly impact its success. Positive attitudes, enthusiasm, and a willingness to adapt instructional practices are essential for overcoming implementation challenges (Johnson et al., 2020).

Teacher Knowledge

Teachers must possess the necessary knowledge and skills to effectively implement the curriculum. Continuous professional development opportunities and access to relevant training can enhance teachers' readiness to implement the curriculum (Glickman & Sullivan, 2019).

Structural and Cultural Constraints Structural Barriers

Structural constraints within the educational system, such as bureaucratic processes and rigid policies, can impede curriculum implementation efforts. Flexibility and adaptability are essential for navigating these structural barriers (Clark & Martin, 2018). Cultural Challenges

Time Constraints

Planning and Preparation Time

Insufficient time for lesson planning and preparation can hinder teachers' ability to deliver high-quality instruction. Adequate planning time is necessary for developing engaging lessons that align with curriculum standards (Roberts & Johnson, 2019).

Lack of Administrative Support

According to Lewis (2021), teachers face barriers to curriculum implementation due to a lack of administrative support. Without support from school leaders, teachers may struggle to integrate innovative instructional practices into their teaching. Lack of encouragement for field trips and concerns about expenses further exacerbate these challenges (Lewis, 2021).

Addressing these barriers requires a multifaceted approach, including professional development opportunities for teachers, adequate resource allocation, supportive school leadership, and policies that promote flexibility and innovation in curriculum implementation. By addressing these challenges, educators can enhance the effectiveness of curriculum implementation and improve student outcomes.

Resources

Resources are regarded as the most important support structure because curriculum management depends largely on resources available in schools. Implementation of a curriculum change without the relevant resources to teach it would cause stress and strain leading to dire consequences and impacting on the teachers" morale to implement the planned curriculum changes. Lack of resources necessary for the execution of teaching and learning can inhibit effective curriculum implementation

Solutions to Barriers of Curriculum Implementation

Providing professional development education for teachers Karakuş (2021), have considered several solutions to mitigating barriers to effective implementation of new curriculum, pointed that the teacher is central to implementation and requires effective professional development to do so. Vander Ark et al.'s (2020), insisted that to address the barrier of inadequate skills to implementing curriculum, effective implementation requires six phases of professional learning. Therefore, knowledge and skill development on the content of the curriculum is key in effective implementation.

Increasing teachers' motivation

Another solution to barriers in curriculum implementation is increasing teachers' motivation. For their intrinsic motivation, it will be valuable to increase their professional knowledge, profession competence, interest and self-confidence for the teaching profession.

Provision of adequate resources

There is need to ensure that English teachers are well equipped in both material and human resource and ensure that teachers have sufficient mastery of content and varied methods of teaching.


CONCLUSION
