



# Systematic Review and Metadata-Analysis of Covid-19 Detection and Classification Using Convolutional Neural Network and Chest x-ray images- recent advances

#### ABSTRACT

Several works were published in regards to the and early detection of COVID-19 via mathematical modelling and Convolutional neural network. The aim of this work is to provide the research community with systematic overview of the methods used in these studies as well as a collection of available open-source datasets in regards to COVID-19. In all, 51 journal articles, reports, fact sheets, and websites dealing with COVID-19 were studied and reviewed. It was found that most mathematical modelling done were based on the Susceptible-Exposed-Infected-Removed (SEIR) and Susceptible-infectedrecovered (SIR) models while the implementations were done via Convolutional Neural Network (CNN) on X-ray and CT images. In terms of available datasets, they include aggregated case reports, medical images, management strategies, healthcare workforce, demography, and mobility during the outbreak. Both Mathematical modelling and CNN have both shown to be reliable tools in the fight against this pandemic. Several datasets concerning the COVID-19 have also been collected with their respective sources. However, much work is needed to be done in the diversification of the datasets. Other CNN and modelling applications in healthcare should be explored in regards to this COVID-19.

#### INTRODUCTION

The World Health Organization declared that new coronavirus disease 2019 (COVID-19) was a Public Health Emergency of International Concern on January 30th 2020 (Sohrabi C, et al. 2020). By then there were a total number of 7818 confirmed cases of COVID-19 globally with more than 1370 severe cases and 170 deaths. The bulk of which was found in China (WHO, 2020). Over the course of a few weeks the disease has propagated across the boundaries of China infecting nearly every country. In recent years, various CNN techniques where deployed in detection of COVID-19 using Chest X-ray image and CT image. (Fangoh & Selim, 2020) presented a CNN-XGBoost model use for Covid-19 detection in chest X-ray images. The proposed model integrates the feature extraction technique of

CNNs with XGBoost prediction capabilities and a machine learning technique called tree boosting. (Srinivasan, Singh, Biradar, & Revathi, 2021) proposed an enhanced model for detection of person, covid-19 social distance defilement detection, facial detection and face masks detection through object detector, CNN and clustering based binary classifier. (Rahman et al., 2021) proposed the application of diverse image development method, namely, histogram equalisation (HE), CLAHE, balance contrast enhancements technique (BCET), gamma corrections, and image complements on detection of covid-19.

The U-Network algorithm was newly developed which was compared with the standards U-Network algorithm for lungs segmentations. (Chaudhary et al., 2021) proposed

deep learning technique, called the Efficient-COVIDNet CNN used in COVID-19 detection with Chest-X-ray images. The proposed model exceeds prior algorithm and achieved accuracy of +2% with advanced sensitivity and positive predictive outcomes. The EfficientNet CNN was executed on public COVIDx dataset, which consist of 14000 X-ray images with highest number of positive cases of COVID-19. (Mishra, Singh, Joshi, & Engineering, 2021) proposed a deep learning and CNN technique for Covid-19 detection using the Chest X-ray dataset, created from the mixture of public X-ray images from infected patients. Different CNN classifiers were applied, such as NASNetLarge, Inception-V3, DenseNet-201, ResNet-152-V2, Xception, VGG-16, VGG-19, InceptionResNet-V2 and MobileNet-V2

Tang et al. (2021) proposed a deep CNN model used for COVID-19 detection through th application of Chest X-Ray images. The proposed model was aim at examining the best achievement of CNN models (ResNet-V101, SqueezeNet, DarkNet-V19, VGG16, and VGG19.) appropriate for detecting COVID-19 using chest X-ray dataset obtained from private and public domain. Madaan et al. (2021) proposed CNN model with image classification named XCOVNET used for detection of COVID-19 using X-ray images. The proposed model detects covid-19 by dividing the 392 datasets into positive and negative X-ray infected images during the first part, while the second part trains and fine tune the network. (Khan & Park, 2021) presented a light-weight CNN technique used for detection of COVID-19. The proposed model was trained on 22,000 X-ray datasets. Their research was conducted on a binary dataset of COVID-19 patients and X-ray image of normal lung. Polat, Özerdem, Ekici, Akpolat, and Technology (2021) proposed CNN based algorithm used for automatic detection of COVID-19 with chest images of computed tomography (CT). the proposed model employed the ground truth from images screen by radiologist, which was analyse for image segmentation procedure, using the 16040 CT images gotten through segmenting images to raw. In this paper, a review of the CNN and various dataset used in the study, performance and evaluation of COVID-19 is presented. The paper is divided into four parts, the first presents the method and material used in the study of the pandemic, the second presents the various CNN techniques in covid-19 detection and evaluation, the third part review some limitation, and in the fourth part a list of available datasets for COVID-19 is presented.

### LITERATURE REVIEW

Fangoh and Selim (2020) presented a CNN-XGBoost model use for Covid-19 detection in chest X-ray images. The proposed model integrates the feature extraction technique of CNNs with XGBoost prediction capabilities and a machine learning technique called tree boosting. (Srinivasan, Singh, Biradar, & Revathi, 2021) proposed an enhanced model for detection of person, covid-19 social distance defilement detection, facial detection and face masks detection through object detector, CNN and clustering based binary classifier. Umri, Akhyari, and Kusrini (2020) present a covid-19 detection model aim at investigative the 100 X-ray chest images of covid-19 victims and chest images of 100 X-ray. The proposed model adopts the hybridization of Contrast Limited Adaptive Histogram Equalization (CLAHE) and CNN technique to design and analyse the dataset of different instances in achieving a good detection outcome. Bassi and Attux (2021) proposed covid-19 image detection using dense CNNs and Transfer learning (TL) to handle chest X-ray image classification according to 3-labels: COVID-19, pneumonia, and normal. The proposed model fine-tuned networks that are pre-trained on ImageNet with double TL method and NIH Chest X-ray14 dataset.

Narin, Kaya, Pamuk, and Applications (2021) proposed five-pre-trained CNN-based model namely. ResNet50. ResNet101. ResNet152, InceptionV3 and Inception-ResNetV2, design for Covid-19 pneumonia patient detection applying chest X-ray images. The proposed model designed three distinct binary classifier using COVID-19, normal. viral pneumonia and bacterial pneumonia as classes

with cross validation. (Rahman et al., 2021) proposed the application of diverse image development method, namely, histogram equalisation (HE), CLAHE, balance contrast enhancements technique (BCET), gamma corrections, and image complements on detection of covid-19. The U-Network algorithm was newly developed which was compared with the standards U-Network algorithm for lungs segmentations. (Das et al., 2021) presented a Deep CNN-based model for detection of COVID-19 infected victims using the images of Chest X-Ray. The proposed model used various state of the art CNN models such as, DenseNet201, Resnet50V2 and InceptionV3 which were trained separately with separate prediction outcome.

Islam, Islam and Asraf (2020) presented the amalgamation of two deep learning algorithm, that is, CNN and Long-short-term-memory (LSTM) to detect COVID-19 automatically using Chest-Xray images. For detection through the extracted features, the proposed model used feature extraction and LSTM algorithm. (Ismael & Şengür, 2021) proposed a deep learning framework applied in detection and classification of COVID-19 and images of normal Chest X-ray using

feature extraction, fine-tuning CNN, and training of an improved images. ResNet18, ResNet50, ResNet101, VGG16, and VGG19 were applied for extracting deep features, while Support Vector machine (SVM) was used for classification with linear quadratic, Gaussian and cubic functions of Kernel. (Dutta, Roy, & Anjum, 2021) presented the application of transfer learning technique with CNN for COVID-19 disease detection using CT images presented. The proposed system was developed using multilayer CNN with transfer learning Inception V3 model.

Karthik, Menaka anad Hariharan (2021) proposed customised CNN model that mines data shapes to captures delicate differences amid ill and normal-X-ray which could further allow automation of learning in latent feature. The proposed model acquires some exceptional convolutional structure of the filter for different types of pneumonia, by limiting some filters from the layers of the convolution to attain maximum respond to a specific type of COVID-19 and pneumonia.

#### **REVIEW METHODOLOGY**

The review methodology chapter illustrates the review stages design to review the state-of-the-art works in the field of covid-19 detection and classification systems. We further elucidate the selection technique of the state-ofthe-art studies which was achieved through a set of two criteria: inclusion and exclusion rule. The review is divided into four parts each dealing with a specific aspect like Mathematical modelling, CNN applications, performance evaluation and available datasets. For each of the two parts, the items reviewed were presented in summary of each journal. In all a total number of 51 journal articles, reports, fact sheets and websites were reviewed. The items reviewed were all published between 2019 to 2022. Table 1 shows the

priorities. The summary of the research gaps analysed in the review papers are clearly discuss as follows:

- Fangoh and Selim (2020) provides a research gap for their architecture, which include the improve hyper parameter tuning and use of various base models for transfer learning and also more vigorous experiment on the outcome of validation and testing sets for CNN models training.
- 2. The model achieved great in terms of accuracy and prediction time; the following areas were identified as the research gap which required further improvement. Firstly, it takes longer time in processing video on person detection module. An improve person detection model could be implemented to reduce the prediction time with better accuracy. Secondly, the computation for social distancing and the classification of mask should be separated to run concurrently and adopt parallelism. Lastly, the dataset is not widely used for all system due to lack datasets.
- Bassi and Attux (2021), the clinical research and huge datasets are required to guarantee the generalisation of quality output. In the future, the classification achievement of various CNN models can be tested by adding the quantity of COVID-19 chest X-ray images in the dataset (Narlin et al., 2021).
- 4. Islam et al. (2020) provided the following gap, firstly, lack of available dataset of COVID-19 images, secondly, their work concentrates on posterior-anterior (PA) sight of X-ray, therefore it can't distinguish some views of X-rays like anterior-posterior (AP), lateral, and many more. Thirdly, the outcome of the proposed model wasn't compared with radiologists.
- Ismael and Şengür (2021) Presented a future work, stating that more images of COVID-19 chest X-ray should be

provided using deeper CNN models to execute the COVID-19 detection. In addition, lung diseases should also be considered because COVID-19 infection shows various growth having dissimilar imagistic structures, and also the use of GUI to assist radiologist in COVID-19 detection

- 6. Karthik et al. (2021) stated that in the future, the model should be extended run with different pneumonia, some lung infections to acquire definitive structure that will assist radiologists.
- Oyelade et al. (2021) recommended a future research direction by stating the exploring high value of chest-X-ray images evolving new cases to fine tune the CNN model. The also stated the deployment of their model on web and mobile apps for laboratory operation
- 8. Tang et al. (2021) provided a research gap stating that the training set and the through validation set data augmentation, can extend translation, rotation, shearing, cropping, and image scaling. This technique can further overwhelm the overfitting in training the model. In addition, longer training of the CNN models through higher epochs number could be considered, which will enhance accuracy performance of the classification. Lastly.

#### CONCLUSION

In conclusion, COVID-19 has spread rapidly all over the world creating an emergency situation. Various CNN models have both shown to be reliable tools detection of this pandemic. Most of the implementations were Convolutional Neural Network (CNN) on X-ray and CT images. Several datasets concerning the COVID-19 have been collected and shared open source. 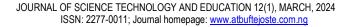
