The consequences of drug abuse among young Nigerian adults are severe, encompassing health underperformance, problems. academic unemployment, criminal behavior, and strained family relationships. Additionally, drug abuse contributes to the burden on the healthcare system and hampers economic development due to the loss of productive workforce.

Records identified from database after searching was 1327 articles, duplicate articles were 54, after removing duplicates, 1273 articles were screened. 856 articles were removed because title and abstract did not match. This leaves us with 417 papers which was sorted and retrieved, 319 was removed after sorting. The remaining 98 articles were considered using the inclusion and exclusion criteria and we had 8 papers left because the rest did not meet the criteria.

PRISMA 2020 flow diagram for updated systematic reviews which included searches of databases and registers only

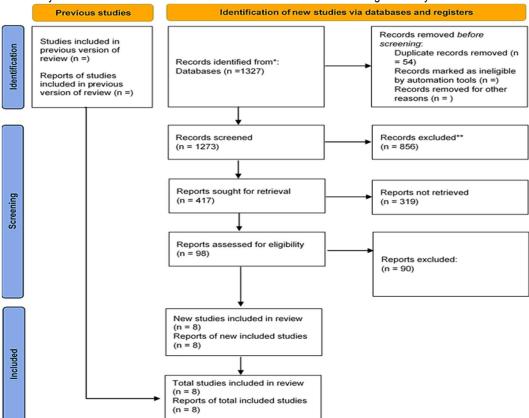


Figure 1: Preferred Reporting Items for Systematic Review and Meta-Analyses (PRISMA) 2020 flow diagram.
