



# Application of Green Chemistry for Environmental Protection and Economic Development in Nigeria: Issues and Challenges: A Review

The term green chemistry is defined as, "The design, development, and implementation of chemical processes and manufactured products to reduce or eliminate substances hazardous to human health and the environment". (Anastas & Warner, 1998) "Green Chemistry" is the universally accepted term to describe the movement towards more environmentally acceptable chemical processes and products (Marteel-Parris and Abraham. 2014). It encompasses education, research, and commercial application across the entire supply chain for chemicals. Green Chemistry can be achieved by applying environmentally friendly technologies some old and some new. While Green Chemistry is widely accepted as an essential development in the way that we practice chemistry, and is vital to sustainable development, its application is fragmented and represents only a small fraction of actual chemistry (Anastas and Eghbali, 2010).

## The need for Green Chemistry

Chemistry has played a vital role in improving our life but all these developments are responsible for various environmental problems. Some examples can be mentioned here for chemical, which were synthesized for the benefit of human beings, has other detrimental effects like chlorofluorocarbons (CFC pesticides. as refrigerants), Dioxins, Thalidomide drug. Some diseases, which became famous by the discharge of poisonous pollutants from the industries, were Minamata disease (mercury poisoning), Itai-Itai (cadmium Disease poisoning), Methaemoglobinaemia (excessive amount of nitrogen fertilizers) etc. On the basis of what has been stated, it is clear that most of the environmental and health problems would not have been there, had the various industries followed the basic norms. It is in this context that green chemistry plays a vital role in keeping the environment clean. The concept of green chemist addresses environmental issues in an economic profitable manner. Green chemistry must permeate not only to the chemical industries, but it is necessary to bring about changes at the grass root level (Anastas and Warner, 1998).

#### **Principles of Green Chemistry**

The twelve principles of green chemistry were introduced by Paul Anastas and John Warner in 1998. They are a guiding framework for the design of new chemical products and processes, applying to all aspects of the process life-cycle from the raw materials used to the efficiency and safety of the transformation, the toxicity and biodegradability of products and reagents used. They were briefed recently into the more suitable and memorable acronym, productively (Anastas and Warner, 1998).

The principles of green chemistry including.

- 1. **Waste prevention**: It is better to prevent waste, than to treat or clean up waste after it is formed.
- 2. Atom economy: Synthetic methods should be designed to maximize the incorporation of all materials used in the process into the final product
- 3. Less harzadous chemical synthesis: Practicable, synthetic methodologies should be designed to use and generate substances that possess little or no toxicity to human health and the environment.
- 4. **Design for energy efficiency** Chemical products should be designed to preserve efficiency of function while reducing toxicity.
- Safer solvent and auxiliaries: The use of auxiliary substances (for example solvents, or separation agents) should be made unnecessary wherever possible and innocuous when used.
- 6. Use of renewable feedstock: Energy requirements should be recognized for their environmental and economic impacts and should be minimized. Synthetic methods should be conducted at an ambient temperature and pressure.
- Reduce derivatives: Unnecessary derivitization (blocking group, protection/deprotection, and temporary modification of physical/chemical

processes) should be avoided whenever possible.

- Catalysis: Catalytic reagents (as selective as possible) are superior to stoichiometric reagents.
- 9. **Design for degradation**: Chemical products should be designed so that at the end of their function, they do not persist in the environment and break down into innocuous degradation products.
- 10. **Real time pollution prevention:** Analytical methodologies need to be further developed to allow for real-time, in-process monitoring and control prior to the formation of hazardous substances.
- 11. Safer chemistry for accident prevention: Substances and the form of a substance used in a chemical process should be chosen to minimize the potential for chemical accidents, including releases, explosions, and fires.

#### Reasons for Green Chemistry Principles

Green chemistry is aimed to help practitioners involved in the invention, design, and application of chemical products and processes to reduce or eliminate the use and generation of hazardous substances (Pietro, Anastas, Black, Breen, et al. Tumas, 2000). The principles promote environmental chemistry at all levels: research, reduction to practice, education, national and international policy, and public perception. They help chemists and chemical engineers design more environmentally, benign products and processes through the selection of alternative feedstock. reagents, synthetic transformations, solvents, reaction conditions, and end products, as well as the design of safer chemicals. For instance, when considering what feedstock to use in generating a particular compound, the green chemist will explore renewable feedstock whenever practical.

There is no guarantee that such renewable feedstock is possible for a given reaction nor, if they are, that they will provide a net

environmental benefit. Nonetheless, the principles of green chemistry provide a set of design criteria and goals that can help improve the environmental performance of new products and processes. As they begin to apply the principles of green chemistry, chemists are discovering many pathways toward environmentally greener designs. For instance, synthetic catalysts and biocatalysts, such as enzymes, offer a variety of alternative synthetic pathways that are consistent with the principles of green chemistry. These catalysts also enable the use of alternative reagents and feedstock previously impractical with conventional chemistries. The two crosscutting enabling technologies hold much promise in fulfilling the expectations for green chemistry (Roberto Ballini, 2009).

For example, such processes might involve developing new energy resources to meet societal needs; but to be sustainable, they must also be economically competitive and not cause harm to the environment or human health (National Research Council, 1999).

In a world with a continuously increasing population and limited resources, the idea of a sustainable development is of major importance is it for the future. Only research and innovation will allow the development of economic and social networks and processes that fulfill the requirements of sustainability. The future has to be planned with visions, creativity, and fantasy, including brand new approaches and the exploration of the unknown (Cliff, *et al.*, 2004).

It plays a key role in different energy science, and the manufacture of innovative technique to make solar cells, fuel cells, and batteries for storing energy. In Nanoscience and technology, green chemistry also highly used. Since main goal of green chemistry is to minimize or eliminate waste in the chemical industry, it has inspired the creation of many green "next generation" catalysts (Anastas and Horvath, 1997).

## **Environmental Protection**

The role areen chemistrv in environmental protection is truly phenomenal. By encouraging the use of biodegradable and nontoxic chemicals along with promoting energy efficient production approaches, green chemistry significantly reduces the potential harm to ecosystems. Basically by adopting green chemistry principles, we reduce environmental pollution at its source. This involves the modification of equipment, technology, processes, products and raw materials in a way that the amount of pollutants or contaminants released in the environment is reduced (Tyson, 2007).

#### Green Chemistry for Safety Improvement

As green chemistry promotes the development of safer chemicals and processes, it minimizes exposure to hazardous substances that can pose risk to human health. In addition, green chemistry advocates for environmentally friendly manufacturing processes that decreases emissions of pollutants to improve air quality both indoors and outdoors (Garyali *et al.*, 2013).

# Green Chemistry in Pharmaceutical Industry

In pharmaceutical industry green chemistry plays an important role and makes a revolution in it. A chemical company now makes ibuprofen (painkiller) in a three-step rather than a six-step process (Abuhijleh, 1994). Zocor (simvastatin), leading drug for treating high cholesterol, conventionally synthesized using a multistep method concerning huge quantities of hazardous reagents that formed a big amount of toxic waste. A bio-catalysis company, Codexis developed a new technique for synthesizing the drug using an engineered enzyme and a low-cost feedstock. The chemotherapy drug paclitaxel (marketed as Taxol) was made by take out from yew tree bark, a process that used a large amount of solvent for killing the tree. The drug is now made by growing tree cells in a fermentation vat (Garyali et al., 2013).

#### **Energy Conservation**

Green chemistry is of fundamental importance for energy conservation as it focuses on developing and implementing energy efficient processes. The goal is to design sustainable technologies that require less energy to function properly. One-way green chemistry achieves energy conservation is by replacing stoichiometric chemical processes with more energy efficient catalytic alternatives. Moreover, green chemistry prioritizes the development of renewable feed stocks as an energy source, to protect nonrenewable resources and decrease greenhouse gas emissions (Foster ET AL., 2009).

#### Resources Efficiency

Green chemistry emphasizes overall resource efficiency by encouraging the use of raw materials and utilizing limited resources in a sustainable manner. Resource efficiency also involves designing processes that generate less waste. By doing so, we maximize the amount of desired products synthesized and minimize the formation of unwanted by products. Additionally, green chemistry principles ensure that the loss of valuable materials is kept at a minimum by incorporating multi step separation and purification techniques.

#### Sustainable Manufacturing

Green manufacturing is a holistic approach to producing less harzadous goods that minimize negative environmental impact. It can be achieved by using environmentally friendly materials, activities, and technologies that reduce the ecological footprint. Adopting sustainable manufacturing processes is key to receiving all other benefits of green chemistry (Nydia and Cecile, 2018).

While green chemistry is crucial for reducing or preventing environmental damage, its principles have an impact on the financial resources the government and firms require to overcome ecological problems. By reducing the production of waste, green chemistry ensures that the costs associated with waste disposal are minimized as well. Chemists from all over the world are using their creative and innovative skills to develop new processes, synthetic methods, analytical tools, reaction conditions, catalysts etc. under the new green chemistry cover (Okonkwo, Okunola and Ezeanyanaso, 2010). Some of these developments are: There several controls that can be manipulated at the different stages of chemical manufacturing process

Using alternative feedstock starting 1. materials: Selection of the starting materials has a major effect through the whole synthetic pathway. It determines what hazards will be faced by the workers extracting shippers transporting the substance, chemist handling the substance. It also predetermines possible future risk from the end products and waste. Using more environmentally benign alternative feedstock improve the may environmental profile of the whole process.

- 2. Using alternative reagents: Reagents are needed to transform the starting molecules into a target substance. Reagents are not necessarily consumed and are often recycled, but can still bear harm to people and environment exposed to the process. At this point, a chemist must balance the criteria of chemical efficiency and availability with potential hazard.
- 3. Using alternative solvents: Solvents are very common focusing point because a wide range of syntheses are performed in a liquid media. Many of the currently used solvents are volatile organic compounds. Many of those are responsible for air quality problems (smog, etc.) when released to air. While traditional organic solvents are easily available, well characterized, and regulated, there is a push for alternative systems that are more environmentally benign in the long run aqueous solvents, ionic liquids, immobilized solvents, supercritical fluids, etc.
- 4. Changing target product: chemistry is function oriented the target chemical is needed to perform a certain function or possess certain properties. This avenue is related to the search of the alternative final product, which may require radical change in the way synthesis is done.
- 5. **Process monitoring:** real time measurements (sensing) of process parameters and concentrations sometimes provide valuable information and hints how the process should be turned to avoid adverse effect or risk. Also, process monitoring may open avenues for making the process more cost effective.
- Alternative catalysis: catalysis bears enormous benefits, not only from the standpoint of technical efficiency. Environmental benefits results from the use of much smaller amount of reagents in catalyzed reactions, which otherwise would contribute to the waste stream.

Using fewer chemicals is also economically profitable. It should be noted, though, that many classes of catalysis (e.g. heavy metals) are very toxic. Hence the challenge of alternative catalysis is to develop environmentally benign options.

# Barriers to the implementation of Green Chemistry

- 1. **Economic and financial**: occasionally green chemistry is more expensive than conventional routes and future benefits are uncertain.
- Regulatory: emphasis is on exposure reduction and not on hazard reduction, lack of global harmonization on regulation and environmental policy, insufficient funding for research and regulatory incentives.
- Technical: non availability of suitable substitute reactions and solvent system, non-availability of trained chemist and engineers, poor knowledge about existing green products and processes and non-sharing of relevant information among industries

- Organizational: problems arise from intra organizational conflicts, lack of support at executive or technical level and lack of understanding in sales and marketing.
- Cultural: poor awareness and wrong conception about efficiency and cost of green reactions among consumers and general public.
- Definition and metrics: poor guidance on best practice and sufficient teaching on sustainable chemistry, difficulty in measuring greenness of a reaction and conducting multi-dimensional optimization.

However, before Green Chemistry can contribute fully to this area, it must be integrated into the discipline of chemistry itself. This requirement presents a number of major challenges to the chemical profession. Chemists will need to integrate into pure chemistry the question of why not a particular technology should be abandoned, improved or adopted on environmental protection basis. These questions must become as important in research and education and made as concrete as the ubiquitous question associated with what comprises chemical technology and how it actually works (Clark, 1998).

Certainly, the largest sustainability issues where chemists have so much to offer will require new approaches that can only be built with long term commitment. For example finding an efficient way of converting solar to chemical energy is a large sustainability issue. The culture of present day chemistry places too many short

term obstacles in the path of research problems of this type. Thus, the culture must adapt to recognize that certain sustainability problems will require novel approaches with inherently longer incubation periods. Chemists must learn how to better evaluate and sustain research programs. Rather than that of rapid publications of incomplete research work, which offer reasonable promise of bringing within the fullness of time, those critical advances that will genuinely promote the cause of sustainability. The science of chemistry cannot escape this growth and remain meaningful and important to humanity. Chemistry exerts an enormous influence on human action and is thus inextricably intertwined with the forces that guide human actions especially ethnics and certain forms of passion.

As such, the power of scientific objectivity will be more openly directed by the action and passion such as our love of life and our desire to protect it. These forces are fully capable of directing chemists towards research that really matters to each and every human living and the future generations. (Okonkwo and Ezeanyanaso 2010). Finally, chemistry will have much to offer by becoming more meaningful to humanity, increasing in attractiveness as a career choice, growing to be more worthy of support, spawning large economic developments and new progressing to be interesting and compelling if chemists work to define and follow their natural and unique role in achieving a virtuous civilization that sees broad validity within the community of living things to the claim of existence in an environment of natural creations.

# CONCLUSION AND RECOMMENDATIONS

With the ever-growing human population, environmental pollution, depletion in supply of non-renewable energy sources, high cost of living, and incessant power failures, Nigeria needs an alternative energy source, more environmentally friendly products, and processes that are more reliable, safer, secure, and affordable. Research and development in green chemistry is the only key to an industrialized, technologically advanced, economically vibrant, and safer Nigeria.
