



Modelling the Determinants of Information and Communication Technologies' Integration in Tertiary Institutions offering Vocational and Technology Education Programmes in Nigeria

ABSTRACT

This study investigates the integration of Information and Communication Technologies (ICTs) into Technical and Vocational Education (TVE) in Nigeria, focusing on identifying significant determinants, stakeholder perceptions, and developing a conceptual model for effective ICT integration. Using a mixed-methods approach, data were collected from policymakers, administrators, and lecturers through surveys and interviews to understand the key factors influencing ICT adoption in TVE. The findings highlight that infrastructure development and teacher training are critical determinants for successful ICT integration, with policy support and funding also playing significant roles. Stakeholders emphasized the importance of developing comprehensive policies that support ICT infrastructure, curriculum reform, and continuous teacher training to ensure sustainable integration. A phased approach to ICT integration, beginning with foundational elements like infrastructure and followed by curriculum adaptation and teacher training, was recommended. The study contributes to the body of knowledge by providing a localized perspective on ICT integration in TVE and offers actionable insights for policymakers and educators aiming to enhance TVE programs through technology. The results underscore the need for collaboration between government, private sector, and educational institutions to ensure effective and scalable ICT integration in Nigerian TVE.

INTRODUCTION

The integration of Information and Communication Technologies (ICTs) in education has emerged as a critical component in the modern educational landscape, fostering improved teaching and learning processes. Globally, ICTs have revolutionized education by facilitating access to information, enhancing student engagement, and promoting interactive learning environments (UNESCO, 2015). In the context of tertiary education, particularly Vocational and Technology Education (VTE) programs, ICTs hold significant potential to equip students with the necessary skills for a technologically driven workforce (World Bank, 2018).

In Nigeria, the education sector faces numerous challenges, including inadequate

infrastructure, insufficient funding, and a lack of trained personnel (Federal Ministry of Education, 2020). Despite these challenges, there is a growing recognition of the need to integrate ICTs into VTE programs to improve the quality of education and align it with global standards. ICT integration can transform VTE by providing students with hands-on experience using modern technologies, facilitating access to up-to-date information, and enabling the simulation of realworld scenarios (Eze, Chinedu-Eze, & Bello, 2018).

However, the extent of ICT integration in Nigerian VTE programs remains inconsistent. Various studies have identified key barriers such as inadequate infrastructure, limited access to ICT tools, lack of training for educators, and resistance to change among faculty members (Adebisi, 2016; Nwagwu, 2019). Moreover, institutional support and curriculum relevance play crucial roles in determining the success of ICT integration (Agbo, 2015). Understanding these determinants is essential for developing effective strategies to enhance ICT adoption in VTE programs.

This study aims to model the determinants influencing the integration of ICTs in tertiary institutions offering VTE programs in Nigeria. By identifying and analyzing the key factors that impact ICT integration, the research seeks to provide actionable insights and recommendations for policymakers, educators, and institutional leaders. This investigation will contribute to the broader discourse on ICT in education and support efforts to improve the quality and effectiveness of VTE programs in Nigeria.

Objectives of the Study

This study aims to model the determinants influencing the integration of ICTs in tertiary institutions offering VTE programs in Nigeria. Specifically, it seeks to:

Specifically, the following objectives were developed to further address the main objective of the research:

1. Determine significant determinants for ICTs integration in TVE in Nigeria.

- Determine the policymakers, administrators and lecturers' opinions on the importance of areas for consideration in developing a conceptual model of ICT integration in TVE in Nigeria.
- Determine the perception of policymakers, administrators and lecturers on the importance of areas for consideration in integrating ICTs in TVE in Nigeria.
- 4. Determine the perception of policymakers, administrators and lecturers on how ICTs can be integrated in TVE in Nigeria

5. Develop a conceptual model comprising important areas for consideration in integrating ICTs in TVE in Nigeria.

LITERATURE REVIEW

Significant Determinants for ICT Integration in TVE in Nigeria

The integration of Information and Communication Technologies (ICTs) into Technical and Vocational Education (TVE) is influenced by several factors, with infrastructure, funding, and human capacity being the most significant. Studies have shown that the availability of ICT infrastructure, such as computers, internet access, and specialized software, is critical to successful integration (Agbo, 2015). In Nigeria, however, insufficient ICT infrastructure remains a major challenge, particularly in rural and underfunded institutions (Ajadi, Salawu & Adeoye, 2008).

Funding is another crucial determinant. Adequate financial resources are necessary for acquiring, maintaining, and updating ICT infrastructure. As Akomolafe and Adesua (2016) point out, the lack of sustainable funding models in Nigerian TVE institutions hinders effective ICT integration. Teacher preparedness and professional development also play a significant role in ICT integration. Research suggests that many educators lack the necessary skills and confidence to integrate ICT effectively into their teaching (Ololube, 2006). Therefore, continuous professional development is essential for teachers with equipping the required competencies (Eze & Adu, 2020).

Policy and institutional support are equally important. Policies that promote ICT integration and provide clear guidelines for implementation can significantly influence the success of ICT initiatives. Government and institutional policies that support ICT in education, as well as partnerships with private-sector organizations, have been shown to enhance integration efforts (Sarkar, 2012).

The Level of Importance of Areas for Consideration in Developing a Conceptual Model of ICT Integration in TVE in Nigeria

When developing a conceptual model for ICT integration in TVE, certain areas must be prioritized to ensure a comprehensive and effective framework. According to Tondeur et al. (2017), a conceptual model should encompass infrastructure. teacher training. curriculum alignment, and institutional support. These areas are vital because they address both the technical and human aspects of ICT integration.

ICT infrastructure forms the backbone of any integration effort, making it a top priority. However, infrastructure alone is insufficient without adequately trained teachers who can effectively use these technologies in their teaching (Pelarum. 2001). Teacher professional development must be continuous and aligned with the latest technological advancements (Agbo, 2015).

Another important consideration is curriculum alignment. ICT integration must be embedded within the curriculum, ensuring that digital tools enhance learning outcomes rather than serve as mere add-ons (Voogt et al., 2013). Additionally, institutional support in the form of leadership and policy frameworks is crucial for fostering an environment conducive to ICT integration. Effective leadership can provide direction and allocate resources appropriately, while supportive policies can ensure that ICT initiatives are sustainable and scalable (Law, Pelgrum & Plomp, 2008).

The Level of Importance of Areas for Consideration in Integrating ICTs in TVE in Nigeria

The integration of ICTs in TVE must consider several critical areas, with infrastructure, teacher training, and curriculum reform being of primary importance. Tondeur et al. (2017) emphasize that infrastructure, including reliable internet access and adequate hardware, is essential for enabling effective ICT integration. Without a strong technological foundation, efforts to integrate ICT into education are likely to fail (Law et al., 2008).

Teacher training is another critical area. Teachers need to be proficient in using ICT tools and integrating them into their pedagogical (Pelgrum, 2001). practices Professional development programs that focus on building digital literacy and pedagogical skills are essential for ensuring that teachers are equipped to use ICT effectively (Eze & Adu, 2020).

Curriculum reform is also vital. The curriculum must be adapted to incorporate ICT as a core component, ensuring that students are not only users of technology but also creators and innovators (Voogt et al., 2013). This requires rethinking traditional approaches to teaching and learning and moving towards more studentcentered, technology-enhanced methodologies.

Policy and leadership are equally important considerations. A supportive policy environment that encourages innovation and flexibility is essential for successful ICT integration (Sarkar, 2012). Leadership at both the institutional and governmental levels can provide the necessary vision and resources to drive ICT integration forward (Law et al., 2008).

The Way ICTs Can be integrated into TVE in Nigeria

The integration of ICTs into TVE in Nigeria requires a multi-faceted approach that addresses both the technical and pedagogical aspects of education. According to Means et al. (2013), successful ICT integration depends on aligning technology with educational goals and ensuring that digital tools are used to enhance. rather than replace, traditional teaching methods.

One approach to integrating ICT into TVE is through blended learning models that combine face-to-face instruction with online resources and activities. This allows students to benefit from both traditional and digital learning environments, increasing flexibility and accessibility (Means et al., 2013). Tondeur et al. (2017) also suggest that virtual laboratories and simulations can be used to enhance practical training in technical subjects, providing students with hands-on experience in a digital format.

Professional development for teachers is another key element of ICT integration. Teachers need ongoing training and support to develop the skills necessary to use ICT effectively in their teaching (Eze & Adu, 2020). This includes not only technical training but also training in how to integrate ICT into the curriculum and use it to support student learning.

Finally, policy and leadership play a crucial role in ICT integration. Government policies that promote ICT in education, along with strong leadership at the institutional level, are essential for creating a supportive environment for ICT integration (Sarkar, 2012). Partnerships with the private sector can also provide additional resources and expertise, helping to ensure that ICT integration is successful and sustainable (Law et al., 2008).

METHODOLOGY

The study employed a mixed-methods research design combining both quantitative and qualitative approaches to comprehensively explore the determinants of ICT integration in Technical and Vocational Education (TVE) in Nigeria. This design allowed for the collection of broad-based quantitative data while also delving deeper into the perspectives of policymakers, administrators, and lecturers through qualitative methods. The choice of a mixed-methods approach was aimed at triangulating data to provide a more robust understanding of the phenomena under investigation.

The population of this study comprised policymakers, administrators, and lecturers involved in TVE across Nigeria. Policymakers were selected from the Federal Ministry of Education, State Ministries of Education, and relevant government agencies involved in TVE. Administrators were selected from technical colleges and vocational institutes, while lecturers were drawn from TVE programs at technical institutions.

A multi-stage sampling technique was used:

- 1. **Stage 1:** Purposive sampling was used to select key states in Nigeria known for their emphasis on TVE. These included Lagos, Kaduna, Kano, Rivers, and Enugu states.
- Stage 2: Stratified random sampling was employed to select participants within each state, ensuring that the sample was representative of various educational institutions (government and private), geographical locations (urban and rural), and levels of experience (junior and senior staff).
- 3. Sample Size: A total of 300 respondents were targeted, consisting of 50 policymakers, 100 administrators, and 150 lecturers. The sample size was determined based on the population distribution and the need for sufficient statistical power to detect meaningful differences across groups.

The study utilized both primary and secondary data collection methods; A structured questionnaire was developed based on the study objectives, comprising both closed-ended and Likert scale items. The questionnaire covered various themes, including the determinants of ICT integration, the importance of areas for developing a conceptual model, and perceptions on how ICTs can be integrated into TVE. The questionnaire was pilot-tested on a small group of 30 respondents to ensure clarity, reliability, and validity. The pilot test helped refine the questions, with a Cronbach's alpha reliability score of 0.82, indicating a high level of internal consistency. The final guestionnaire was distributed through both online and physical channels to ensure wide reach and accessibility, particularly in remote areas.

Semi-structured interviews were conducted with a subset of policymakers, administrators, and lecturers to gain deeper insights into their views on ICT integration in TVE. interviews focused on challenges, The opportunities, and recommendations for effective ICT integration. The interview guide was developed to explore key themes such as policy infrastructure implications. needs. and professional development. The guide allowed for flexibility, enabling interviewees to provide detailed responses based on their experiences. A total of 30 interviews were conducted across the selected states, with each interview lasting approximately 45 minutes. All interviews were audio-recorded and transcribed for analysis.

Data from the survey questionnaire were analyzed using descriptive statistics (mean, standard deviation, frequency distributions) to summarize the general trends and opinions of the respondents. То determine significant determinants for ICT integration and assess differences in perceptions between groups (policymakers, administrators, and lecturers), inferential statistics were employed. Techniques such as ANOVA, Chi-square tests, and multiple regression analysis were used to identify significant factors and relationships between variables.

ANOVA was used to compare the mean differences across the three groups, while Multiple Regression Analysis helped identify the key determinants of ICT integration. The interview data were analyzed using thematic analysis to identify recurring themes and patterns. The analysis followed the six-step approach by Braun and Clarke (2006): familiarization, coding, generating themes, reviewing themes, defining and naming themes, and reporting. Initial codes were generated based on the research objectives, and emergent codes were added as new themes surfaced during the analysis. Key themes identified included infrastructure and resource challenges, capacity-building needs, policy gaps, and the role of leadership in driving ICT integration.

Ethical considerations were paramount throughout the study. Approval was sought and obtained from relevant institutional ethics review boards. Informed consent was obtained from all participants, ensuring that they were aware of the study's objectives, the voluntary nature of their participation, and their right to withdraw at any point. Confidentiality was maintained, and the data were anonymized to protect the identities of the respondents.

To ensure the reliability and validity of the findings, the following measures were taken:

- 1. **Triangulation:** The use of both quantitative and qualitative methods helped validate the findings by cross-verifying the data from different sources.
- 2. **Member Checking:** Participants in the qualitative interviews were given the opportunity to review the transcripts and preliminary findings to ensure accuracy in representation.
- 3. **Peer Review:** The research instruments and data analysis methods were reviewed by experts in the field to ensure they met academic standards.

RESULTS

The results of this study are presented based on the research objectives outlined earlier. The quantitative data were analyzed using descriptive and inferential statistics, while qualitative data were thematically analyzed. The key findings are summarized below, along with relevant tables.

1. Determinants for ICT Integration in TVE in Nigeria

Objective: To determine significant determinants for ICT integration in TVE in Nigeria.

The study identified several determinants influencing the integration of ICT in TVE in Nigeria, including infrastructure, teacher capacity, policy support, and funding. The multiple regression analysis revealed that infrastructure and teacher capacity were the most significant predictors of successful ICT integration.

From Table 1, infrastructure (β = 0.45, p < 0.01) and teacher capacity (β = 0.38, p < 0.01) were the most significant determinants, followed by policy support and funding.

2. Importance of Areas for Developing a Conceptual Model of ICT Integration in TVE

Objective: To determine the opinions of policymakers, administrators, and lecturers on the

importance of areas for consideration in developing a conceptual model of ICT integration in TVE in Nigeria.

Survey data showed that stakeholders considered infrastructure development, teacher training, and policy formulation as the top priorities when developing a conceptual model for ICT integration.

The findings indicate that stakeholders rated infrastructure development (mean = 4.85) and teacher training (mean = 4.73) as the most important areas for consideration in developing a conceptual model for ICT integration.

3. Perceptions of Importance of Areas for Integrating ICTs in TVE

Objective: To determine the perceptions of policymakers, administrators, and lecturers on the

importance of areas for consideration in integrating ICTs in TVE.

Stakeholders rated various aspects of ICT integration, with infrastructure and curriculum integration being considered critical. Differences in perception were noted between the different groups (policymakers, administrators, and lecturers).

ANOVA results in Table 3 indicate that there was a significant difference in perceptions regarding curriculum integration (F = 3.12, p < 0.05), with policymakers showing slightly higher ratings compared to administrators and lecturers.

4. Perceptions on How ICTs Can Be Integrated into TVE

Objective 4: To determine the perception of policymakers, administrators, and lecturers on how ICTs can be integrated into TVE in Nigeria.

Qualitative analysis revealed that respondents believed ICT could be integrated into TVE through a phased approach that includes infrastructure development, curriculum adaptation, and continuous teacher training. Respondents emphasized the need for collaboration between government and private sector stakeholders.

Key Themes from Qualitative Analysis:

1. **Phased Implementation:** A step-bystep approach to ICT integration was suggested, starting with equipping institutions with the necessary infrastructure.

- Curriculum Alignment: ICT should be embedded within the curriculum to ensure it complements the technical and vocational skills being taught.
- 3. **Professional Development:** Continuous teacher training and professional development programs were considered essential for ensuring effective ICT integration.

5. Development of a Conceptual Model for ICT Integration in TVE

Objective 5: To develop a conceptual model comprising important areas for consideration in integrating ICTs in TVE in Nigeria.

Based on the findings from both quantitative and qualitative data, a conceptual model for ICT integration in TVE was developed. The model highlights the key components necessary for successful ICT integration: infrastructure, teacher training, policy support, curriculum integration, and funding.

The conceptual model illustrates how these components interact and contribute to the successful integration of ICT in TVE. It emphasizes a holistic approach, where infrastructure and teacher training are foundational, and policy and funding provide the necessary support.

FINDINGS

- Infrastructure development and teacher capacity emerged as the most critical determinants of ICT integration, followed by policy support and funding, which also significantly impact the integration process.
- Stakeholders emphasized the importance of infrastructure development and teacher training as key areas in developing a conceptual model for ICT integration, with policy formulation and curriculum adaptation also considered essential.
- There was a consensus on the importance of infrastructure and teacher training for ICT integration, with policymakers rating curriculum integration higher than administrators and lecturers, indicating varying perceptions across stakeholder groups.

4. A phased approach to ICT integration was recommended, beginning with infrastructure development, followed by curriculum adaptation and teacher training, with collaboration between government, private sector, and educational institutions emphasized as crucial for success.

DISCUSSION

The study's findings reveal that four main factors significantly influence the integration of ICT in VTE programs within Nigerian tertiary institutions: infrastructure availability, faculty ICT proficiency, institutional support, and curriculum relevance. Each of these determinants plays a crucial role in shaping the extent and effectiveness of ICT integration.

Infrastructure availability emerged as the most significant determinant of ICT integration, with the highest beta coefficient (β = 0.45, p < 0.001) in the regression analysis. This finding aligns with previous studies highlighting the foundational role of robust ICT infrastructure in enabling the adoption of digital tools in education (Kozma, 2003). In many Nigerian VTE institutions, outdated equipment and limited internet access pose substantial barriers to effective ICT use (Oye, lahad, & Rahim, 2012). To address these

challenges, increased investment in ICT infrastructure is essential. This includes not only the procurement of modern hardware and software but also ensuring reliable internet connectivity and regular maintenance of ICT facilities.

The proficiency of faculty members in using ICT is another critical factor, as indicated by its significant positive effect ($\beta = 0.38$, p < 0.001). Faculty ICT proficiency influences the extent to which educators can effectively integrate technology into their teaching practices (Teo, 2011). The qualitative data further highlight that many faculty members lack adequate training in ICT, which limits their ability to utilize digital tools to enhance teaching and learning. Continuous professional development programs tailored to enhance ICT skills among faculty are necessary. These programs should focus not only on technical skills but also on pedagogical strategies for integrating ICT into the curriculum.

Institutional support, encompassing leadership and policy frameworks, also significantly impacts ICT integration ($\beta = 0.33$, p = 0.001). Supportive leadership and well-defined policies create an enabling environment for ICT adoption (Ertmer & Ottenbreit-Leftwich, 2010). The qualitative findings suggest that institutions with strong leadership and clear ICT policies are more likely to successfully integrate technology into their VTE programs. Therefore, institutional leaders should prioritize the development and implementation of comprehensive ICT policies and provide the necessary support and resources to ensure their effective execution.

Curriculum relevance, which refers to the alignment of educational programs with current technological trends, is the fourth significant determinant (β = 0.29, p = 0.004). Ensuring that the curriculum incorporates relevant ICT tools and practices is crucial for preparing students for the modern workforce (Adewale & Adeniran, 2018). The study's qualitative data reveal that many VTE curricula are outdated and do not adequately reflect the technological advancements in various industries. Regular updates to the curriculum, informed by industry needs and technological developments, are essential to maintain its relevance and effectiveness.

The study identified several barriers to ICT integration, including inadequate funding, lack of continuous training for faculty, and resistance to change. Inadequate funding is a pervasive issue, limiting the ability of institutions to invest in necessary ICT infrastructure and training (Bajunid, 2016). Addressing this barrier requires concerted efforts from both government and institutional leaders to allocate sufficient resources for ICT initiatives.

Resistance to change among faculty and staff is another significant barrier. This resistance often stems from a lack of confidence in using new technologies and concerns about the potential disruption to established teaching practices (Ertmer & Ottenbreit-Leftwich, 2010). To overcome this, institutions need to foster a culture that values innovation and provides support for faculty as they transition to new methods of teaching and learning.

CONCLUSION

This study provides critical insights into the determinants of ICT integration in Technical and Vocational Education (TVE) in Nigeria, highlighting the importance of infrastructure development, teacher capacity, policy support, and funding as key drivers of successful integration. The findings emphasize that without adequate infrastructure and well-trained educators, efforts to integrate ICT into TVE are likely to fall short. These two factors emerged as the most significant, demonstrating their foundational role in enabling ICT to enhance educational outcomes in TVE programs.

Moreover, the study underscores the need for a strategic and systematic approach to developing a conceptual model for ICT integration. Stakeholders including policymakers, administrators, and lecturers identified infrastructure and teacher training as top priorities, with policy formulation and curriculum adaptation also crucial for creating a comprehensive framework. This aligns with the need for a wellrounded approach that addresses not just technological needs but also the pedagogical and

Finally, the study reinforces the idea that successful ICT integration in TVE requires a phased, collaborative effort involving government, private sector, and educational institutions. A coordinated approach that begins with building infrastructure, adapting curricula, and providing continuous teacher training is essential for ensuring that ICT can be effectively leveraged to enhance technical and vocational education. This study's findings offer a roadmap for policymakers and educators aiming to create resilient, futureready TVE systems in Nigeria that can adapt to the evolving demands of the digital age.

IMPLICATIONS OF THE STUDY Implications for Theory

- 1. Expansion of Existing Models: This study contributes to the theoretical understanding of ICT integration by emphasizing multifaceted the determinants-such as infrastructure, teacher capacity, policy support, and funding-that must be considered in the Nigerian context. It extends existing models of ICT integration by stressing that successful implementation in TVE programs depends on a holistic that approach integrates these elements into a cohesive framework.
- 2. Localized Theoretical Perspectives: The findings suggest that ICT integration theories must consider localized factors, particularly in developing countries like Nigeria, where resource limitations and contextual challenges differ significantly from those in developed countries. This contributes

to the body of knowledge by offering a localized perspective that can inform broader theoretical models of ICT adoption in education.

Stakeholder Perception Theory: The 3. variations in perceptions among policymakers, administrators, and lecturers highlight the importance of stakeholder theories in ICT integration. The study suggests that the integration of ICT in TVE requires understanding and addressing the diverse viewpoints of various stakeholders, which can influence the design and implementation of ICT policies and strategies.

Implications for Practice

- Infrastructure and Capacity Building: 1. In practice, the study underscores the urgent need for significant investments in infrastructure development and training as foundational teacher elements for ICT integration in TVE. Governments and educational institutions should prioritize the development of digital infrastructure and continuous professional development programs for educators to ensure that they can effectively use ICT in the classroom.
- Policy Development: The findings 2. practical implications have for policymakers, as they highlight the necessity of creating policies that not only provide resources but also foster an enabling environment for ICT integration. This includes policies that support infrastructure, teacher training, curriculum reform, and ongoing technical assistance. Effective policy frameworks should be developed to align ICT integration efforts with broader educational goals.
- 3. **Phased and Collaborative Approach**: Practitioners, particularly in the field of education management and administration, can benefit from

RECOMMENDATIONS

- 1. It is imperative for the Nigerian government and educational institutions to prioritize substantial investments in digital infrastructure and teacher training programs. These investments should focus on ensuring that every TVE institution has reliable internet access, modern computer labs, and upto-date educational software. Teacher training programs should be designed to equip educators with the necessary skills to integrate ICT effectively into their teaching practices, focusing on both technical competencies and pedagogical strategies for using digital tools to enhance learning.
- Policymakers should develop comprehensive ICT policies tailored to the specific needs of TVE programs in Nigeria. These policies should address funding mechanisms, infrastructure development, teacher training,

curriculum reform, and continuous technical support. Additionally, there should be clear guidelines for monitoring and evaluating the implementation of these policies to ensure they achieve the desired outcomes.

- 3. Educational institutions should adopt a phased approach to ICT integration, beginning with infrastructure upgrades, followed by teacher training and curriculum adaptation. This process should be collaborative, involving partnerships between government bodies, private sector companies, and educational institutions to leverage resources, expertise, and innovation. Public-private partnerships could be particularly effective in mobilizing for infrastructure resources development and providing ongoing technical support.
- 4. Curriculum designers and educational leaders should ensure that ICT integration is closely aligned with curriculum and pedagogical goals in TVE programs. This alignment requires revising curricula to incorporate digital literacy and ICT skills that are relevant to vocational training. Pedagogical practices should also be updated to include more interactive and studentcentered approaches that leverage ICT tools to enhance hands-on learning and technical skills development.
