Creating a Digital Twin and IoT-Enabled Reinforcement Learning Algorithm to Optimize the Health Status of Poultry Production in Agriculture

Where θ is the policy parameter α is the learning rate and $I(\pi_{\theta})$ is expected reward under policy π_{θ} .

Reward function: the reward function R(s,a) could be expressed as(Minna, 2018).

This collected data is fed into a digital twin that simulates the real-world poultry environment and interacts with a reinforcement learning agent. The agent employs a Q-learning algorithm to make decisions regarding the adjustment of these environmental parameters. Each iteration involves analyzing the collected data, updating the policy based on the rewards received, and implementing actions that lead to improved health metrics. The system runs for over 1,000 iterations to ensure robustness and adaptability to changes in the environment. The steps of the reinforcement learning algorithm are as follows:

- Step1. Initiate the cage system parameters for optimization.

- Step3. Apply the digital twin and IoT-enabled reinforcement learning algorithms.
