STRUCTURAL DEFORMATION MONITORING OF KIRI DAM, ADAMAWA STATE, NIGERIA

Abstract

Deformation of structures is a major hazard worldwide and has in recent years become a challenge to surveyors, civil engineers, geologist, and other professionals of geosciences and environmental engineers. In this paper, a study was conducted on Kiri Dam where monitoring data for 12 epochs were used for both vertical and horizontal displacements. These data were collected using heights leveling and offset distance measurements for the vertical oscillation and horizontal displacements respectively. Observation equation method of least squares adjustment was used for adjusting the heights difference and the offset distances were adjusted by arithmetic mean method. The study revealed the minimum and maximum vertical movement of -238mm and 131mm which occurred in 1998 and 1996 at chainages 800m and 1300m respectively. For the horizontal displacement, there was a minimum and maximum of -161mm and 186mm which occurred in 1996 and 1989 at chainages 1400m and 1500m respectively. The results of the adjustments were tested using the null hypothesis, H_o at 5% significance level in which ANOVA method was used for both vertical and horizontal displacements. The results of the statistical test also revealed that the structure is experiencing small random movement in both vertical and horizontal sections which is not imposing significant force on the structure. It is recommended that the dam structures be monitored periodically to avert any catastrophic consequences.

Introduction

Engineering structures (such as dams, viaducts, bridges oil farm tanks, e.t.c.) are subject to deformation when adversely affected by physical and chemical processes. This deformation could be caused by deflection in both horizontal and vertical axes due to factors such as changes of ground water level, tidal phenomena, loading and pressure, tectonic phenomena etc, which may occur gradually over a long period of time.

Monitoring and analysis of these structures constitute a special branch of geo-science. Several techniques for measuring and monitoring deformation are grouped into two, geodetic and nongeodetic techniques (Ono, et al 2005).

Generally, dams are constructed for various purposes such as hydroelectricity, agriculture, water supply system etc. Consequently, dams need to be monitored periodically to mitigate any danger that may result from deformation. Steward and Sakiri (2002) stated some factors that could precipitate the failure of dams as ground water pressure and stresses within the ground or structure itself, surface displacement structure or the surrounding bedrock. Monitoring and measurement of these effects are the fields of civil engineers. The concern of surveyors is to determine whether there are displacements in horizontal or vertical, in relation to a fixed reference space (Kulkarni, 1999). system in These displacements refer to the downstream face of the dam, its crest could be foundation bedrock. Measurements made are aimed at determining the variation in positions with time. Any detected displacement will provide an avenue for analysis and prediction.

The primary applications of distances and directions measurements as suggested by Chrzanowski (1993) and Wan Aziz et al (2000) are to provide a continuing surveillance of the structure and warning of any dangerous developments.

Statement of Problem

Kiri dam was constructed between1976 and 1980 by Upper Benue River Basin Development Authority of Nigeria. One of the reasons for constructing the dam was for irrigation farming at Savannah Sugar Company Limited. Over the years, the top of the dam become an access route to Shelleng and other neighbouring towns in Shelleng Local Government Area of Adamawa State. The external forces (loads) exerted on the dam structure as a result of daily vehicular traffic becomes a matter of concern. Recently, Adamawa State Government in its efforts to provide the State with alternative source of electricity proposed to develop a hydro-electric plant at Kiri dam (Abubakar, 2011). The proposal intends to modify the existing dam structure in order to accommodate the installation of intake facilities in the reservoir (Dilli, 2011). Based on these observations, it becomes imperative that an immediate study be conducted on the dam to ascertain its stability by checking the reliability of the dam.

The information obtained could be used to indicate whether:

1- the structure is stable and consequently safe.

2- the structure is experiencing small random movements which are not imposing significant forces on the structure.

3- the structure is experiencing small, localized systematic deformation i.e. as caused by

seasonal effect like the volume of water which may not be significant, or.

4- the structure is experiencing deformation which increases as a function of time. They may indicate that remedial measures have to be taken in some cases in order to avoid catastrophic consequences.

Aim of the Study

This paper aims at vertical and horizontal displacement observations and analysis of Kiri Dam Structures in Adamawa State, Nigeria.

The Study Area

Kiri Dam is located in shelleng Local Government Area of Adamawa State, Nigeria. The dam wall is a linear figure located between longitudes $12^0 09^1$ E and $12^0 10^1$ E, and latitudes $09^0 42^1$ N and $09^0 48^1$ N. The dam is bounded by Shelleng District in the North, Borong District in the South, Longuda District in the West, and Yungur District in the Eastern part. The wall of Kiri dam covers a distance of 1km across river Gongola, and it has an embankment of 20m above river bed. Below are photographs of some elevations of the dam.

Data Collection Procedure

For the purpose of this study, the authors' intention was to use the data collected from Upper Benue River Basin Development Authority of Nigeria for a period of 20 years (1989-2009). But due to unavailability of some data, only 12 years data was used, i.e. 1989, 1991, 1996-2004 and 2009. And at the beginning of each set of observations, in-situ test was carried out on the two control points (H_{DB2} and H_{DB3}) located on the opposite sides of the dam, which are off the structure, and are connected to the A-Chain of the Nigerian Primary Triangulation Network. For each test conducted, it was found that the two controls were in-situ. The heights of the controls H_{DB2} and H_{DB3} provided by Upper Benue

River Basin Development Authority of Nigeria are 174.228m and 174.441m respectively. While the computed heights from the observations carried out by a precise automatic level of 1mm accuracy are 174.22804127m for H_{DB2} and 174.44093015m for H_{DB3} .

Observations for each campaign (year) were taken on monthly bases by Kiri dam survey unit. The mean of the observed offsets and levels for 12 campaigns for both vertical and horizontal movements were obtained and used to monitor the following:

- 1. Deflection in horizontal axes: This involved the use of two control points at the abutment of the dam which define the axis, along with monitoring stations established at 100m interval on the crest of the dam. During the period of measurements, a theodolite was used in defining a fixed reference axis with stations H_{DB2} and H_{DB3} as controls. This was followed by taking offsets from each monument to the centre line.
- 2. Vertical displacement: The relative settlement of the control points on the crest of the dam were measured with precise automatic level instrument relative to the bench marks. The relative elevation change for each bench mark at each survey period was measured. Vertical displacement / settlement were then computed.

Data Quality

For horizontal movement, a Kern theodolite with an accuracy of 0.5sec was used. And for vertical movement, a Kern automatic level instrument with an accuracy of 1mm was also used. The two instruments are of second order, but it is recommended that second order instruments can be used for first order work provided redundant observations are carried out. Hence, 30 different sets of redundant observations were made for both horizontal and vertical movements respectively to improve the accuracy of the work.

Computations

The mathematical equation associated with observation equation can be written in matrix form as:

- L = Vector of the observations.
- V = Vector of the discrepancies which is also the unknown.

The system of normal equation is represented in matrix form as follows:

 $(A^{T}PA)X = A^{T}PL$ 1.1 i.e. $X = (A^{T}PA)^{-1} A^{T}PL$ 1.3 The results of the mean height differences, offset differences, adjusted offsets, mean offset displacements, and the least squares estimates (X) for 12 epochs are presented in appendices 1, 2, 3, and 5 respectively.

Precision: - Based on Ayeni, (2001) it involved computing

i. The residual (v) = Ax-L (Appendix 6) ii. A posteriori variance (2) = $\frac{V^{T}PV}{M-N}$ (Appendix 7) iii. Variance –co variance () = $^{2}(A^{T}PA)^{-1}$ (Appendix 8)

iv. M and N are number of observations and unknown parameters respectively.

Reliability

Reliability = r_1/r_2

Where $r_1 = a$ posteriori standard error of observation, and $r_2 = a$ priori standard error of the observation. Appendix 9 shows the reliability result.

The greater the number of observations, the lower the ratio should be. And low ratio indicates high reliability, but a ratio of one indicates complete unreliability.

Numerical Analysis

The results of both vertical and horizontal movements were tested using null hypothesis, H_0 which stated that: $\mu_1 = \mu_2 = \mu_{3=} \dots \mu_n$ (i.e there is no difference in measurements for all the epochs).

The statistic of accepting or rejecting the stated hypothesis was based on the analysis of the variance (ANOVA). That is, if $F_{cal} > F$ the null hypothesis, H_0 will be rejected at 5% level of significant. That is, there is significant difference between the observations.

Analysis of the Vertical Displacement

Shepher, (1981) explained that test failure can be expected since it is based on the tested population and not on the entire population. Based on the hypothesis earlier stated, the result was tested using Analysis of Variance (ANOVA).

Thus: The Hypothesis;

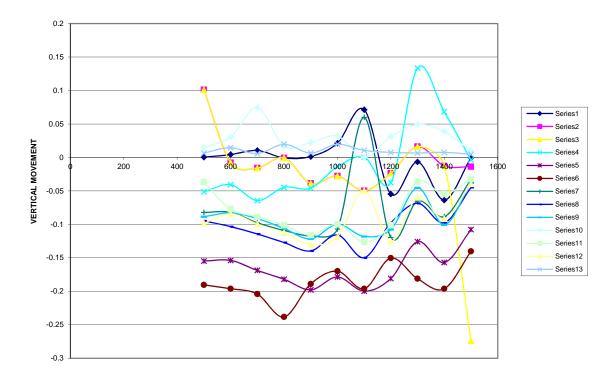
Since $F_{cal} > F$ the null hypothesis, H_0 was rejected at 5% level of significant. That is, there is significant difference between the observations.

From the adjusted movement, the graph of vertical movement is plotted against the chainage distance for every epoch. This portrayed the minimum and maximum movement occurred at the respective chainages for each epoch. The summary is shown in table 2 below:

The maximum vertical movement of the dam is ranged from -274 to 131mm which occurred in 1991 and 1996 respectively. Thus this table 2 depicted that there is random significant oscillation.

Analysis of the Horizontal Displacement

The analysis of the downstream offset movement was tested using the method of the one way Analysis of the variance (ANOVA). It involved splitting of the total variance of the data into meaningful components that measured the different source of variation. The ANOVA was computed using Microsoft ward excel which is shown in table 3 below.

The statistical test was carried out as follows: Hypothesis:

 $H_{0:} \mu_1 = \mu_2 = \mu_3 = ... = \mu_{12}$ (there is no difference in offset distance measured for all epoch).

F = 1.878388

Since $F_{cal} > F$, the null hypothesis, H_0 was rejected at 5% level of significant. That is, there is significant difference between the observations.

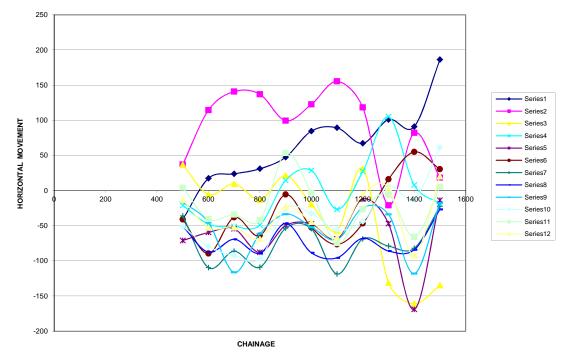
From fig. 4, for the first epoch, the maximum horizontal displacement of 186mm existed at chainage 1500. In the second epoch (1991) the maximum horizontal displacement of 155mm exists at chainage 1100 that is in the same direction to the first epoch. But in the third epoch (1996), the maximum displacement of -161mm exists at chainage 1400 that is in opposite direction to the first two epochs. The 4th epoch reveals the displacement of 105mm at chainage 1300 in the same direction to the first two epochs. At 5th epoch (1998) and 6th epoch (1999), the movement is ranged from -169mm to -40mm at 1400 & 500 chainages respectively. Also, at 7th epoch, the movement is ranged from -

119mm to -23mm at chainage 1100 & 1500 respectively. At 8th epoch, the movement is range from -96mm to -27mm at 1100 & 1500 respectively. At 9th epoch (2002) the movement is range from -118mm to -16mm at 1400 & 500 respectively. At 10th epoch (2003) the movement is ranged from -97mm to 63mm at 800 and 1500 respectively. At 11th epoch (2004) the movement is range from -74mm to 53mm at 900 and 1500 respectively. The displacement ranged from -92mm-21mm at chainages 1400 and 1500 respectively at 12th epoch. Fig. 2 shows that the displacement of the other epochs were not significant as their graphs are about to superimpose.

In nutshell the results indicated that the horizontal

movement is significant but in a random manner.

Research Finding

The major findings of this research are;

- 1. The dam is not stable
- 2. The dam is experiencing small random movements which are not imposing significant force on the dam.
- 3. Statistically, there is deformation (both horizontally and vertically) at 5% significant level during the period under study.
- 4. Based on the graphical representation, the chainage 600,800, 900, 1000 are more vertically stable.
- 5. The vertical movement indicated at chainages 1500 and 1300 was as a result of the load on the structure.

Conclusion

From the observed data and analysis of the results carried out, it was revealed that the structure is experiencing small random movement which, as ascertained by Chm-Chyang(2000) and Brandon (2002), is not imposing significant force on the dam. This is indicated by the graphical representation of the results especially at chainages 1500 and 1300 for the vertical movement and chainages 1500, 1400, 1100, 800 and 700 for horizontal movement.

The statistical test based on the null hypothesis portrayed that, there is significant difference between observations made on each 12 epochs for vertical and horizontal formation respectively at 5% level of significance. The graphical representations also showed that the wall is vertically moving down and horizontally moving in the left hand(downstream) side of the wall. Therefore the sudden movements especially at the chainages mentioned above require regular and rigorous monitoring.
