Remedying *Multicollinearity* in Quantitative Analysis: A Simulation Studies

ABSTRACT

In multiple regression *modeling*, if there is a relationship between x_1 and x_2 , which are all the explanatory variables of y, then the relationship between x_1 and y or x_2 and y is not linear. Linear regression modeling is prone the problem of Multicollinearity as a result of violation of the assumption linearity. But, sometimes in real life data, it is difficult to satisfy the independence of predictor assumption due to the nature of the data leading to the problem of Multicollinearity. It causes interpretation misconceptions if the data set is contaminated with collinear variables. In this study, we restrict in the famous four methods which are Multiple Regression, Ridge Regression, Stepwise Regression and Partial Least Squares Regression. The aim of this study is to improve the remedial procedures for solving Multicollinearity problem in linear regression modeling. Findings from the simulation study shows that the partial least square method is the effective method when there is a change in sample size and number of predictors; it is capable to representing the data well when Multicollinearity problem is present.

INTRODUCTION Concept of Multicollinearity

Multicollinearity is a condition of deficient data, which frequently is encountered in observational studies in which the investigator does not interfere with the study (Lukman et al., 2015). It is obvious (from literature reviewed) that Multicollinearity till date is recognized as a very serious problem in linear regression modeling which lead up in wrong inferences. It is an important problem in linear regression modeling that has received increased attention in recent times (Ayinde et al., 2015; Lukman et al., 2015; Ismail and Manjula, 2016; Olanrewaju et al., 2017).

The linear independence of the predictor variables must be met and is non-negotiable. If x_1 and x_2 are predictors of y and are related to some extent, the severity of such explanation will lead them not to explain the dependent variable.

There is a literature controversy among the researchers as to which technique is optimum when dealing with *Multicollinearity* in regression modeling. Wondola (2020) proposed partial least squares as the best method to deal with *Multicollinearity* problem. In his work he uses five (5) independent

variables and small sample size to test his assertion, but the question is, what will happen when the numbers of independent variables are much and when the sample size is large? Which method will produce efficient estimate when there is change in sample size and also change in the number of independent variables? His work is extended to improve the remedial procedures for solving *Multicollinearity* problem.

Source of Multicollinearity

There are several sources of Multicollinearity and a few of them are as follows:

- Use of defective data collection technique or employing unqualified personnel.
- ii. Faulty experimental design; violation of the pre-set protocol from the design of experiment or getting the wrong data.
- Using a variable that is a sub-set of another variable within the same model which served as a duplicate or identical sister variable.
- iv. Error committed in terms of data coding; and so on. Rupa, 2022)

Impact of Multicollinearity

When multicollinearity exists in the data set, it is likely to:

- i. The estimates will have a large variances and covariance.
- ii. Estimators (OLS) and their standard errors can be sensitive to small changes in the data, i.e. when add or delete an independent variable, the regression coefficients changes sensationally.
- iii. There may be a strong and nonsignificant relationship, which is not possible.
- iv. Confidence intervals on the regression coefficients may vary too wide with the parameter they estimate (over fit the data set).
- v. It can change the signs of the parameter estimated, a positive regression coefficient will be found to have a negative. (Rupa, 2022)

Remedying or Fixing Multicollinearity

Once *Multicollinearity* is identified in the data set, there are several ways of remedying it so as to create an accurate regression model, some of which are:

- Applying a Central Limit Theory by obtaining more data.
- Removing a collinear variable(s) (Kavish – Data Science Blogathon, 2022) (Stepwise Automated Regression).
- iii. Use biased regression techniques in your model (employing biased regression methods).
- iv. Do nothing: (use the traditional OLS method like multiple regression).
- v. Modify the weakest operator to a new look. (Rupa, 2022)

METHODOLOGY

The Ordinary Least Square (OLS)

The ordinary least squares (OLS) estimator is unbiased estimator. It is a tool that allow researcher to examine the relationship and significant effect of a number of independent variables on the dependent variable (Nael, 1994). The main goal of regression model is to minimize the error term and to estimate the parameters. The general linear regression model is given by:

Where Y is an $(n \times 1)$ response vector, X is an $(n \times p)$ matrix of n observations of p predictors.

And

The solution turns out to be a matrix equation, defined by:

In the Presence of *Multicollinearity*, (OLS) estimator could produce large variance, which leads to poor prediction (Ogee *et al.*, 2020). Some researchers are of the view that no single solution exists that will eliminate *Multicollinearity* totally (Allison, 2012; Cohen *et al.*, 2014; Alcacer *et al.*, 2018). Some opined that do nothing, live with what you have (Griffiths *et al.*, 1985; Green, 2003; Cohen *et al.*, 2014; Alcacer *et al.*, 2018).

Ridge Regression

The Ridge regression procedure is intended to overcome the ill-conditioned situation, and is used to improve the estimation of regression coefficients when regressors are correlated and the criterion of goodness of estimation considered in the ridge regression is the minimum total MSE (David, 2004). The ridge regression coefficients are given by:

$$\hat{\beta}(k) = (X'X + kI)^{-1}X'Y \dots 3.5$$

Where k is the ridge parameters and I is the identity matrix. (Imdad and Aslam, 2018_a &b; Al-Hassan, 2007).

Stepwise Regression

variable Automatic selection methods have gained popularity epidemiology and other fields for a number of reasons, including computational simplicity, relative ease of interpretation, selection of nonrelated independent variables (Multicollinearity) and their implementation (Rothman et al., 2008). Stepwise algorithms still remain most widely used variable selection methods with collinear variable (Hutmacher & Kowalski, 2014).

Partial Least Square

Partial least square regression is a recent technique that generalizes and combines features from principal component analysis and multiple regression (Abdi, 2003; Ake & Ulf, 2016; Chadalavada, 2018). It decomposes both X and Y as a product of a common set of orthogonal factors and a set of



specific loadings, so, the independent variables are decomposed as $X = TP^T$ with $T^TT = I$, with I being the identity matrix, which means the issue of *Multicollinearity* has been taking care of (Abdi, 2003; Yizhou, 2009; Chadalavada, 2018; Babar, 2020).

Simulation Study and Analyses

Data set was simulated (Monte Carlo Simulation) using pseudo-random numbers where the response variable is $y_i = \beta_0 + \beta_1 x_{1i} + \beta_2 x_{2i} + \ldots + \beta_L x_{Li} + \varepsilon_i$ with $\varepsilon_i \approx N(0,1)$.

Detecting Multicollinearity

Tolerance

The i^{th} tolerance value is defined as $1-R^2$ where R^2 is the coefficient of determination (multiple determinations) for regression of the i^{th} independent variables.

ii. Variance Inflation Factor (VIF): $VIF = \frac{1}{1-R^2}$

VIF is more than 10, predictors were seriously correlated and need to be address before modeling (Rupa, 2021).

iii. Eigen Values

All Eigen values must all be ≥ 0 , otherwise, the impact of *multicollinearity* is severe.

It is ensured that multicollinearity exists within these data sets corresponding to their respective variables highlighted **boldly** and the severity of such collinear variables need to be addressed before modelling.

RESULT AND COMPARISON ANALYSES

The performance of such operators were ranked in order of strength and importance where the efficiency of the considered methods will be evaluated using R – Squared the coefficient of determination, mean squared error (MSE) and root mean square error (RMSE) to measure how well the regression model fit the data.

Comparison Using R – Square Criteria (R^2)

From among the four techniques, PLS out perform all other techniques in dealing with *Multicollinearity* problem in each case. It remained boldly with a change in the number of predictors (p) as well as change in the

sample size (n). On the other hand, RR technique is the most poorly performed method in dealing with *Multicollinearity* as it has the least values in each case.

RR has the largest MSE's in each case when compared with others whereas PLS has the lowest, indicating that PLS supersede

other techniques when treating *Multicollinearity* while RR is the least.

Result showed that among the techniques PLS outperform others in dealing with *Multicollinearity* problem as it has the lowest RMSE values in each case with changes in the number of predictors (p) and in the sample size (n). Whereas RR technique on the other hand is the most poorly performed method in dealing with *Multicollinearity* as it has the least values in each case hence need to be modified for a better performance.

CONCLUSION

It is sometimes difficult to satisfy the independence of predictor assumption of multiple regression due to the nature of the data leading to the problem of *Multicollinearity*. Despite the violation of such assumption, there are other techniques that handle data set that are contaminated with collinear variable(s). In this research, four alternative methods for solving *Multicollinearity* were comparatively evaluated against each other.

Findings showed that the best estimator for solving *Multicollinearity* problem, which has high efficiency, and performs well in capability, where it has minimum mean square error, the capability measure by root mean square error and coefficient of determination is Partial Least Squares (PLS), and more capability to resist its stance in dealing with *Multicollinearity* for both small and large samples and with small and large number of independent variables.
