This study explores the role of Artificial Intelligence (AI) tools in enhancing library service delivery for students in academic institutions. It aims to assess the benefits of AI in library operations, increase awareness among librarians about AI applications, and outline effective integration strategies. The research examines key challenges faced by Nigerian libraries, including limited technical expertise, inadequate funding for technological infrastructure, and insufficient government support for digital transformation. Through a comprehensive literature review, the study highlights how AI-driven systems can optimize user experiences, with a focus on tools such as chatbots, recommendation engines, and natural language processing (NLP) technologies. These innovations empower students and library staff by facilitating research, improving information retrieval, and supporting personalized learning. Additionally, the paper addresses obstacles to AI adoption, including resistance to change, data privacy concerns, and the ongoing need for staff training. The findings emphasize AI's transformative potential in modern libraries, demonstrating its ability to streamline workflows, enhance accessibility, and offer tailored support to students. Contrary to concerns about job displacement, the study advocates for AI as a complementary tool that enhances librarians' efficiency rather than replacing their roles.

The 21st century has seen a significant rise in Artificial Intelligence (AI) within foreign language education, where it is leveraged to simulate language learning experiences for students. One prominent example is online machine translation (MT), which provides a swift solution for English language learners (ELLs) struggling with written communication (Bahri & Mahadi, 2016; Stapleton & Kin, 2019). However, discussions regarding the effectiveness of AI-driven programs in foreign language instruction remain divided (Briggs, 2018; Qassemzadeh & Soleimani, 2016). While some research highlights critical inaccuracies in direct translations that fail to capture contextual nuances, other studies

emphasize the potential of these technologies in English Language Teaching (ELT), particularly in assessing fluency and grammatical accuracy in second-language (L2) writing (Beiler & Dewilde, 2020; Tsai, 2019).

Technological innovations often follow a "hype cycle," beginning with initial optimism, followed by disillusionment, before ultimately achieving mainstream adoption. The current enthusiasm—and accompanying concerns—surrounding AI exemplifies this cycle. AI encompasses a broad spectrum of approaches, with machine learning emerging as one of its most pivotal components (Hu, Li, & Wright, 2019). The incorporation of AI in library operations is still in its early stages (Cox et al., 2019; Hervieux &

Wheatley, 2021), yet it holds immense potential for revolutionizing access to information through enhanced search functions, intelligent recommendation systems, large-scale digital content classification, transcription tools, and automated translation processes. Nevertheless, AI's integration into libraries introduces ethical considerations (Cox, 2022), prompting fears that it may replace aspects of traditional librarianship. Additionally, concerns regarding equality, diversity, and inclusion (EDI) have emerged, particularly given the perception of AI as predominantly white and male (Cave & Dihal, 2020), further reinforcing gender disparities in the IT sector of library work.

Given these dynamics, this paper aims to define AI from the perspective of librarians. It selectively draws upon existing literature to offer an initial exploration of AI's implications within the library context. Rather than focusing on technical specifications, this analysis is designed for audiences considering AI as a strategic priority in the future of library services

Application of Artificial Intelligence (AI) in Libraries

Traditional manual libraries are increasingly becoming obsolete as advancements in Information Technology (IT), including artificial intelligence (AI), revolutionize librarian performance. Recent literature has expanded the understanding of AI applications in libraries, with significant contributions from Cox (2021), Hervieux and Wheatley (2022), and Huang (2022). This paper adopts a broad and inclusive definition of AI to help readers navigate its complexities. Different library sectors may prioritize specific applications—for example, research libraries and archives benefit from knowledge discovery tools, while public libraries focus on AI's role in information literacy.

AI is increasingly utilized for routine clerical and manual tasks, with two key applications emerging. The first is Robotic Process Automation (RPA), which streamlines repetitive clerical processes (Lin et al., 2022; Milholland & Maddalena, 2022). RPA enables computers to automate manual tasks that involve

repetitive steps with minimal human judgment, such as data collection, processing, and recording outputs. This technology facilitates workflow automation across various library operations, including form processing, data migration, and reconciliation of inputs from different sources. Lin et al. (2022) present a case study illustrating these implementations. To effectively deploy RPA, libraries require skills in workflow analysis and technical expertise in managing automation tools. The second application involves robotics for physical tasks such as sorting returned books or scanning shelves for misplaced items (Tella, 2020; Vlachos et al., 2020).

Additionally, generic robots, like robotic cleaners, are increasingly adopted in library settings. One notable AI-driven system is Automated Storage and Retrieval Systems (AS/RS), commonly referred to as "bookbots," which allow books to be stored in high-density units and retrieved on demand for user access (McCaffrey, 2021; Sproles & Kuehn, 2014). Libraries began implementing AS/RS around 2005, primarily to repurpose shelving space for alternative uses. However, integrating these systems is typically part of major renovation projects and has significant operational implications, as demonstrated in McCaffrey's (2021) case study. Both RPA and robotics aim to improve efficiency and are generally perceived as less disruptive since they relieve library staff from repetitive and mundane tasks.

3. **Automate Routine Tasks** – Machine learning models assist in cataloging, metadata generation, and plagiarism detection, reducing manual workloads for librarians.
4. **Personalize Learning Experiences** – Adaptive AI systems analyze user behavior to suggest tailored research materials and learning pathways.



Moreover, AI-driven analytics help libraries assess usage patterns, predict trends, and make data-informed decisions about resource allocation. Despite these advancements, challenges such as ethical considerations, data privacy, and the need for staff upskilling remain critical discussion points. As academic libraries continue to evolve, the strategic adoption of AI stands as a pivotal factor in ensuring they remain dynamic, accessible, and responsive to the needs of students, researchers, and educators in the digital age.

AI Technologies in Academic Libraries

Olayode (2022) recently conducted a thorough review of AI applications within library contexts. The study categorized the relevant AI technologies into several key areas, including natural language processing, machine learning, and robotics. For instance, the University of Calabar has become a notable example of how AI can be applied practically within library services. The institution employs various AI-driven bots and robots that assist in managing library operations and delivering specific services. These applications not only streamline processes but also improve user satisfaction by making resources more easily accessible.

Chatbots and Reference Services

Nawaz and Salahuddin (2020) explored the impact of AI on library reference services, finding that chatbots are instrumental in providing immediate assistance to users. Chatbots can handle a multitude of inquiries, utilizing natural language processing to interpret user questions and provide accurate answers. This technology is particularly beneficial during off-peak hours when librarians may not be available. Furthermore, the introduction of AI chatbots has contributed positively to user experience, as they can handle frequently asked questions and guide users through library resources without the need for human intervention. This effectiveness raises

awareness about the library's offerings and encourages more frequent use of library resources.

AI and Smart Libraries

The concept of "smart libraries" has emerged at the intersection of AI and academic libraries. Yu et al. (2019) categorize smart libraries as those incorporating advanced technologies such as machine learning and IoT (Internet of Things) devices to enhance user interaction. Features in these libraries may include facial recognition for user identification, automated resource checkout systems, and personalized recommendation engines that tailor services to individual user needs. This evolution indicates that libraries are not only spaces for accessing books but are transforming into dynamic environments that respond to user needs and learning styles.

Applications Beyond Reference Services

Oname and Alex-Nmecha (2020) emphasized a variety of AI applications that extend beyond traditional library functions. They discuss systems designed for effective shelf-reading—ensuring books are returned to the correct place—and management of library resources. Moreover, AI can assist in cataloging tasks, using machine learning algorithms to classify new materials based on existing datasets. The integration of AI into customer interaction forms also stands out. For example, automated systems can send reminders for book returns or alert users about new acquisitions based on their borrowing history. This proactive engagement fosters a seamless and enriching experience for users.

Perception of AI Among Librarians

The perception of AI tools by librarians is critical to the successful implementation of these technologies. Ali et al. (2020) examined this aspect and noted that while librarians recognize the potential of AI for improving services, their readiness to adopt these technologies can vary significantly. Factors influencing librarian attitudes include technological self-efficacy, familiarity with



AI tools, and awareness of the practical benefits of AI implementation.

Al-Amiri and Othman (2022) further this conversation by showcasing successful use cases where robotics and automation have enhanced operational efficiency within libraries. Such examples underscore the need for continuous training and professional development, ensuring librarians are equipped to work alongside AI technologies effectively.

Impact of COVID-19 on AI Adoption in Libraries

The COVID-19 pandemic has accelerated the need for libraries to rethink their service delivery models. Nawaz, Gomez, and Saldin (2020) investigated how AI technologies facilitated library resources and services during this challenging period. Libraries shifted to virtual services, utilizing AI to create a more robust online presence, enabling users to access resources remotely.

AI's deployment during the pandemic has underscored its versatility and potential to address emerging challenges. Libraries adopted AI-driven systems for user identification through speech and typing recognition, monitoring user engagement, and automating responses to recurring inquiries. Such innovations have proven invaluable in maintaining connectivity with library users despite physical closures.

Challenges and Ethical Considerations

Despite the promising applications of AI, challenges abound in its integration into library settings. Ogbodo (2021) raised concerns about ethical implications, particularly regarding user privacy and data security. The use of AI technologies that track user behavior can lead to vulnerabilities if proper safeguards are not established. Librarians need to balance the benefits of personalized services against the risks associated with user data collection. Moreover, the need for a thorough understanding of AI technologies to accommodate their integration in libraries poses another challenge. Continual training and support for library staff are essential

to ensure that librarians can effectively manage and utilize these advanced systems.

The Future of AI in Academic Libraries

As educational institutions continue to adapt to the changing landscape of information access, the future of AI in academic libraries looks promising. Mughali (2019) posits that specialized systems enhanced by AI can further library operations and extend the range of services provided to users. Highly tailored systems such as Refsearch and Plexus Expert exemplify potential advancements in library management, allowing for greater efficiency in acquisition, cataloging, and classification tasks.

Moreover, as discussed by Fernandez (2016), the deployment of AI solutions can relieve librarians from repetitive tasks, allowing them to focus on higher-level functions such as user education, programming, and resource development. This shift not only enhances librarian job satisfaction but also ensures that library services remain relevant and user-centric.

CONCLUSION

In conclusion, the integration of machine learning and AI-driven technologies in academic libraries heralds a transformative era that promises to enhance service delivery and operational efficiency. However, it is imperative for libraries to address inherent challenges associated with AI adoption, such as ethical considerations and the need for continuous staff training.
